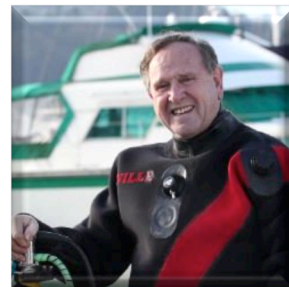


1 Introduction

1.1 Foreword from one of our founding members.

Neville Oldham was one of East Cheshire's founding members and having moved to the south coast often referred to himself as "The Devon Branch of East Cheshire BSAC".

Neville was involved with the preparation of our application for the Heinke Trophy and supplied a number of the pictures and words used in the history section. He had also offered to provide a foreword in his own words, saying "I would be delighted to help with the application". Sadly Neville passed away on the 17th of November 2015 and will be a huge loss for the scuba community in general as well as for East Cheshire Sub Aqua Club in particular. He was a major supporter of the club and an inspiration to many of its members. We are dedicating this application to him and the legacy that he left for the club.

Neville was born in Cheshire in 1935 and spent his formative years on a farm. In 1953 joined the Grenadier Guards. He first started diving in 1956 whilst serving as Assault Pioneer Sergeant during the Suez Crisis when on attachment to 45 Commando attending a minefield and demolition course.

On leaving the Guards he went into construction. To continue diving he joined East Lancashire BSAC and with their help founded the East Cheshire BSAC holding the posts of Chairman, Training Officer and Secretary. In 1979 the Club made him an Honorary Life Member. In 1983 he attained his commercial divers' ticket.

1982 was an eventful year for him, at the beginning of the year along with members of the East Cheshire Club, he was involved with locating parts of the wrecked Penlee Lifeboat (for which the club received formal thanks from the RNLI - see page 10). He also moved to Devon where he started a Diveboat Charter business at Hope Cove and joined the Nautical Archaeology Society SW, serving on the committee as Secretary and Chairman as well as a member of NAS national committee and also became a NAS Part I Instructor.

In 1983 he formed the Bigbury bay investigation team looking for historical wrecks in the SW and in 1989 they were joined by members of Northampton and other Midlands BSAC and formed the South West Marine Archaeology Group with whom they have been fortunate to have located several of South Devon's premier Historic wrecks sites. Erme Ingot site 1000 B.C (for which they won the BSAC Duke of Edinburgh's Jubilee Prize,) Erme Estuary Cannon site 1632, the Salcombe Cannon site 1635 and Salcombe B Bronze Age site 3000 B.C. These are now all protected Historic wreck sites.

He is also the Licensee of the Moor Sand historic site 3000 B.C. Other projects that he was involved with are the investigation of HMS Venerable 1804, The Gossamer 1868, Chanteloupe 1772, San Pedro El Mayor 1588 and the Dartmouth Cannon site 1577. He had been involved in diving for over 50 years.



1.2 The highlights of our application

We strongly believe that East Cheshire Sub Aqua Club deserve recognition for their contribution to the diving scene in 2015 and for furthering the interests and profiles of its members and of BSAC. Working together as a team within the club we have grown our membership and expanded the club's diving and greatly expanded our involvement with other clubs, as well as contributing to both scientific and historical diving projects in the UK. We have also worked very hard to extend our club's reach and benefit outside of East Cheshire by involving other clubs in our social and diving activities in the UK and abroad which we believe has also greatly benefitted the club itself.

Some of the major activities we undertook were:

- We initiated and delivered a project to install a scuba-training platform into Salford Quays that significantly improved the usability of that facility for Dive training. This project has delivered a new facility that is now available to the entire scuba community, both BSAC and other agencies as well, and has generated a lot of interest from a number of other BSAC clubs - see page 94.
- We created a standalone promotional kiosk – it is a computer terminal featuring specialised hardware and software that allows us to promote East Cheshire Sub Aqua Club around the region and can be left in situ with no human support required. It went on tour in 2015 and was used to generate awareness and leads for membership - see page 33.
- We significantly grew our club membership in 2015 against a backdrop of national decline. This was in response to a near crisis situation two years ago when membership levels were in danger of falling below those needed to sustain the club - see page 11.
- We have worked hard to deliver a large amount of training to both our membership and to the wider BSAC community – delivering over 20 SDCs during 2015, which included both our own members and members from over 10 other clubs - see page 41. We also managed to qualify divers into every BSAC Diver Grade in 2015 - see page 42.
- Our club's social calendar was extended in 2015 to deliver a greater number of events, these were opened up to divers from other agencies and clubs in an attempt to widen our links with other like minded divers and extend the appeal and raise the profile of BSAC - see page 84.
- We now coordinate an annual event that is reaching epic proportions, the annual Menai Boat run which involves and raises money for the RNLI. It was featured in Scuba Magazine and attracted over 10 clubs in 2015, 14 RIBs and more than 130 people. We have plans for over 20 boats in 2016 - see page 86.
- We surveyed our members and listened hard to what they wanted from the club; this directed the club committee in its decision-making and drove the delivery of both training and trips ensuring that as a club we delivered what our members wanted - see pages 13 and 58.
- We created our club mission statement and a strategic plan to deliver it - see page 21.

“To protect, maintain, develop and grow the club and its assets to the benefit of its membership with a focus on promoting and delivering more diving and snorkelling activities that meet the preferences and enhance the enjoyment of the members of the club”



1.3 Executive Summary

Key Achievements in 2015:

- We have created a very professional approach to running the club and worked together as a team with focus and drive to deliver a better experience for our members.
- We grew our club's membership by over 20% in 2015 compared to a national decline of 2%
- We grew the number of dives the club conducted by 25% compared to 2014 and over 100% to 2013
- We ran eleven inter-club events (training and socials) with involvement from over 10 different clubs and other diving agencies from across the North-West and beyond.
- We safely conducted over 1,000 club dives in the UK and aboard
- We created links with several new clubs during 2015 and involved them in club events and training
- Delivered a total of 82 try dives and hosted snorkelling courses for 38 Scouts.
- Ran an outreach project to support the **#thisgirlcan** campaign, promoting diving with the Girl Guides, something that the club had not done before as we previously only worked with Scout groups. We also got some national coverage for this via Twitter and two new club members as a result.
- We built and installed a training platform in Salford Quays for use by the entire scuba community.
- We hosted the now annual "Menai Boat Run" with over 10 clubs and 130 participants.
- We qualified people into every BSAC grade from Ocean Diver to First Class Diver during the year.
- We actively developed our instructor team during the year and delivered an Instructor Development Workshop with nine of our team supported by BSAC NW Region.
- Delivered twenty SDCs for our own club members and opened the SDCs to the wider BSAC community.
- Supported and grew our award winning Snorkelling Section.
- Forged links with other BSAC Clubs and independently assisted them with training by giving time from our Open Water Instructors to their training sessions (Richmond SAC and Manchester University SAC).
- Our instructors contributed to the regional coaching team and running the NW FCD group.
- Developed our own instructor team by creating skills videos for our students and running instructor workshops with the BSAC regional coaches.
- Kept our club members engaged and informed with a weekly newsletter, never missing a week thru 2015.
- Provided opportunities for our members to extend their diving experiences and get involved in a number of different projects including The Shipwreck Project, Project Baseline and Seasearch.
- Broadened the depth and type of diving offered to our members following detailed consultation with our diving members.
- Created a new outreach tool with our "Club Kiosk" and sent it on tour around the area driving awareness of the club, generating membership enquiries and promoting diving and BSAC in general.
- Setup our club facilities with boat storage and simple processes to make it easier than ever for members to run and attend diving trips – see page 141.
- Provided a wealth of facilities and equipment free of charge to our members, delivering real value for their £144 annual membership fee (we also maintained it at that level – with no increase in fees for the last few years).
- Introduced the formal role of a Club Safeguarding Officer as well as a new club team structure to better support our expanding activities.
- Implemented a Trainee Code of Conduct and the buddy-guard policy to ensure we involve and engage our younger members and their guardians correctly.
- We put in place a fundraising officer and applied for two Sport England Grants (see page 105).
- We have defined a six-year strategic plan and mission statement for the club, aligned to BSAC HQ's mission which will drive and focus our activity and development over the coming years to ensure we continue to drive forward and develop the club in the long term.

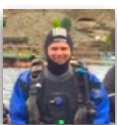

1.5 About East Cheshire Sub Aqua Club (ECSAC)



Paul Tyers – Presently ECSAC Chairman and member for over 37 years.

I have been a member of ECSAC since January 1979 and have served on the Committee as Diving Officer, Equipment Officer, Building Manager, Treasurer and Chairman both currently and for 5 years over the time of our clubhouse build; I am also a Trustee.

I trained to Dive with Trafford SAC then Sale at a time when I moved jobs from Nottingham to Manchester. It took me a year to sell my house and move my family so I needed something to fill my time during the week and was introduced to Sub Aqua. I have always been a water based individual having rowed at school and raced sailing dinghies in my teens and beyond so going underwater seemed like the next step. I was first aware of the sport at the age of 8 when on a family holiday at Tenby and seeing the local diving Club - I am also very keen on seafood!

I started training in October 1974 and qualified as an Advanced Diver (or 2nd class as it was known then) on 16th November 1977.

I bought a house near Macclesfield and was eventually introduced to ECSAC by a neighbour and as I had a young family I was looking for a local family friendly club and I wasn't disappointed. Both my children have grown up on the sides of slate quarries in Wales and on beaches by the sea in all types of weather and they tell me they remember the days with fondness. My son had his first pint at the club bar - of course he was old enough!!!

I've made lifelong friends and have had very special times in some wonderful places with some lovely people both home and abroad. I have dived with wild dolphins both in England and Ireland, basking sharks, manta rays, shoals of barracuda in Sipadan and sea snakes in the South China Sea to mention but a few. ECSAC also introduced me to skiing – seemed like a good thing to do when we couldn't dive so off to Scotland in a bus – I was much younger!

I see my position now as a link between our founders some of whom I have met and dived with and our newer members letting them know what they could achieve with East Cheshire Sub Aqua Club.

1.5.1 The history of ECSAC

The Club was formed in 1960 making it one of the oldest sports diving clubs in the UK and forms part of the British Sub Aqua Association of Clubs. We are BSAC Branch 100 indicating our early affiliation in the history of BSAC.



It was the dream of two men who with drive and passion created the Branch we now have.

The Club's first ever dive, which was under ice in Red Brook Reservoir saw Neville Oldham and Roy Hyde braving the elements in their homemade suits. Clearly they also had a photographer with them who it seems had more sense than to dive in the ice filled pond.



Roy & Neville also assisted the police with in-water searches as at that time the local Police did not have their own dive teams. The two pictures below show them on the first body search the club made for the Police at the Silesian College at Pott Shrigley for a young priest who had drowned while swimming.



The first club meetings were in the Highwayman public house in Rainow which was owned by our founder member Neville Oldham and over the formative years these meetings moved to a coffee bar in Queen Victoria Street and then to a rented house scheduled for demolition in Commercial Road and on to more cosy meets in the bar of the Bate Hall pub all after weekly training sessions in Macclesfield baths on a Thursday night.

We still hold our pool nights on a Thursday to this day.

Our club members can be seen meeting at the Bate Hall pub in the photo on the left taken in 1964. A very smart bunch they look.

The breakthrough for the club came in 1965 when founder Chairman Stewart Davison negotiated a lease on the club's behalf of some premises in Lower Bank Street owned by Frost Mills. An exceptionally lively hot-pot supper with our Landlords as hosts resulted in the rent reduced to peppercorn proportions – a technique still utilised by the club to day to solve tricky problems!



Everybody mucked in with all the building works required to make the building suitable for club meetings and socialising including the installation of the bar, which was a clinker built boat neatly sawn in half. In honour of this, a copy of that boat has been constructed above the existing bar in our new custom-built premises as can be seen in the photo below.



Once the bar became operational club funds rapidly improved and with the help of a grant from the sports council it was not long before the club started to accumulate an enviable array of its own inflatable boats with outboards and an excellent ex-American compressor.

Over the years the club continued to improve and grow with exciting times had by one and all – a truly family club with every one involved.

The stories are endless as you would imagine but a typical one is about a group of six members who caught a train to Holyhead in 1962 and walked with their equipment on their backs to Trearddur Bay complete with camping gear to spend a weekend diving in and around the bay.



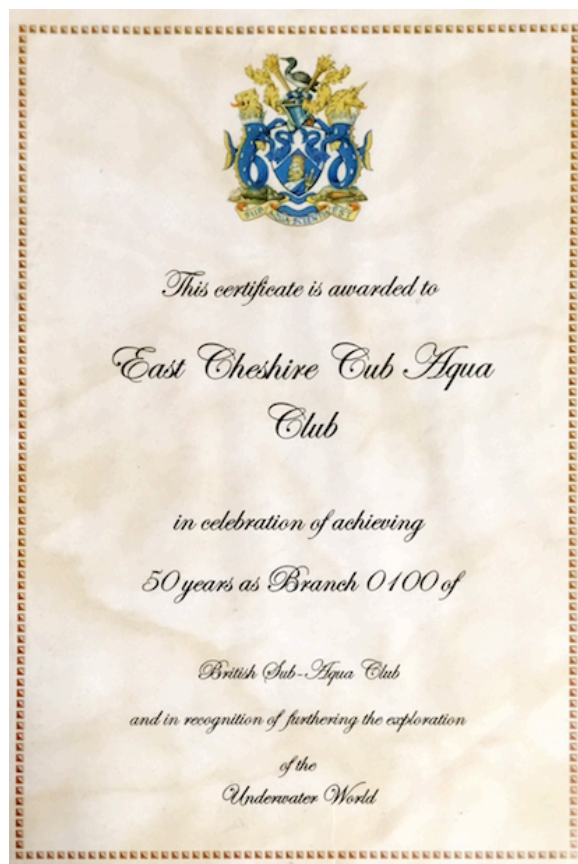
The club has developed over the years training hundreds if not thousands of people how to dive, drive boats and generally how to make the most of our wonderful seas.

The club was forced to vacate our beloved premises when the land was acquired for the building of the bypass (the new Silk Road) but in the true spirit of this merry band of members, which at the time numbered well over 100, this only represented a challenge which resulted in the fine custom built clubhouse we now own. When in 1991 planning permission was granted work commenced on building what must be one of the very best dive club facilities in the UK. (See Section 3.5.7 on page 51 for more details of that).



The 18th September 2010 saw East Cheshire Sub Aqua Club, celebrate its 50th birthday party.

We held a suitably grand party, attended by the Mayor of Macclesfield and his wife; Gordon and Felicity Baxendale, Macclesfield's former MP Sir Nicolas Winterton, the newly elected MP Mr David Rutley and BSAC representatives Phil Clifton and Debbie Powell.



We also had the club's founder and life member Mr Neville Oldham and over 150 past and present members, with some coming from as far as the US just to join in the celebrations.



The highlight of the event for many was the very moving and heart-felt speech by Neville. "It's not the building, or the boats that make the club it's the members" was exemplified by the hard work and commitment put in by so many to make the event the success it was. To say it exceeded expectations is an understatement.

The birthday party was the culmination of a year of activities to celebrate the 50th year of the club which included a 'Diving Through The Ages Event' at Macclesfield leisure centre, where club members had a chance to try a variety of equipment including a hard hat supplied by the Historic Diving Society, the re-launch of the photographic competition and a very special Annual Dinner Dance at the start of the year.



Early Characters of the Club

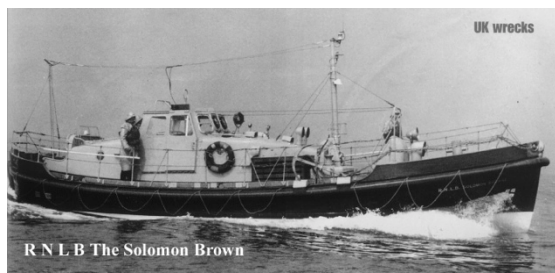


Since then the club has continued to develop, we have faced some challenges but always come out stronger, this application outlines the current position, one of strength we hope driven by the enthusiasm and effort of the current growing membership.



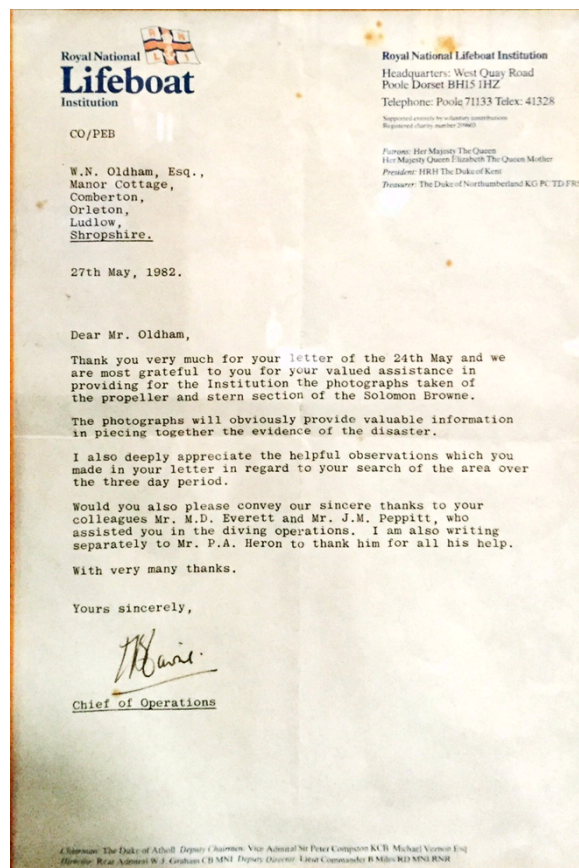
The finding of the stern section of the Solomon Browne by club members

One of the many notable items in the story of the club was our involvement in a piece of maritime history. On 19th December 1981 the Penlee lifeboat the "Solomon Browne"



was launched in hurricane force winds to go to the rescue of the Coaster the "Union Star" that had got into difficulties off the coast of Cornwall. A Sea King Helicopter from RNAS Culdrose was unable to lift any of the crew or passengers from the ship. Whilst the Solomon Browne managed to get 4 of the crew off the "Union Star" the lifeboat made further attempts to rescue the rest of the people on board but to

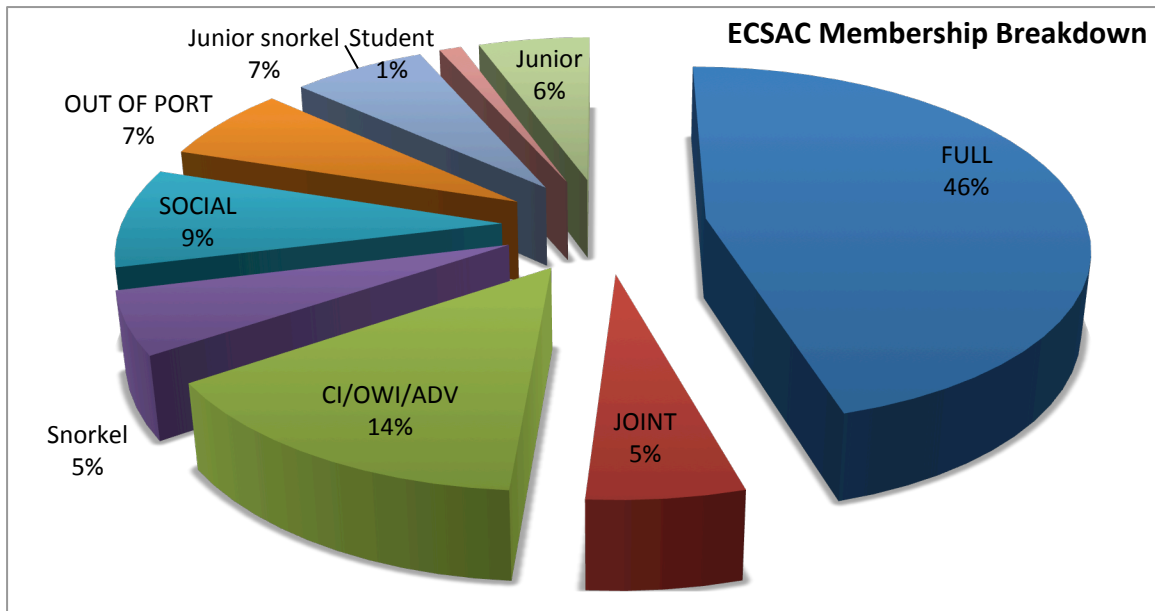
no avail and both vessels were lost together with the loss of all crew and passengers. In total 16 people died. It was one of the worst disasters in the RNLI's history and a devastating blow for the village of Penlee. How, why and where the boats went down remained a mystery despite the RNLI employing a team of professional divers to look for both wrecks for a number of months. The mystery remained unsolved until Easter 1982 when a group of divers from East Cheshire Sub Aqua Club were diving on Buck Rocks out of Lamorna Cove. Here they found a maroon anorak that turned out to belong to the Coxswain Trevelyan Richards of the "Solomon Browne". They left a marker on the anorak and reported the find to Falmouth Coastguard. A further dive was done and the wreck of the "Solomon Browne" was found: a rope was found round one of its propellers and a hatch allowing the crew access to the propeller was missing. The divers who did these initial dives were John Wright, Stuart Andrew (Angus), Pat Heron and Tony Wilkinson. Further dives took place and photographs were taken of the wreck and can be seen in our clubhouse along with the letter of thanks we received from the RNLI. These divers were Neville Oldham, Mick Everett, Mick Pepitt, and Pat Heron. The information provided by ECSAC divers proved invaluable to the inquest into the loss of the "Union Star" and the "Solomon Browne". For a start both were outside the area the professional divers were looking and they were much deeper, over 40m (130ft) rather than 20m (60ft). It seemed that the "Union Star" had been thrown on top of the "Solomon Browne" and it was her rope that had fouled the lifeboats propeller, rendering her unsteerable.



2 Membership

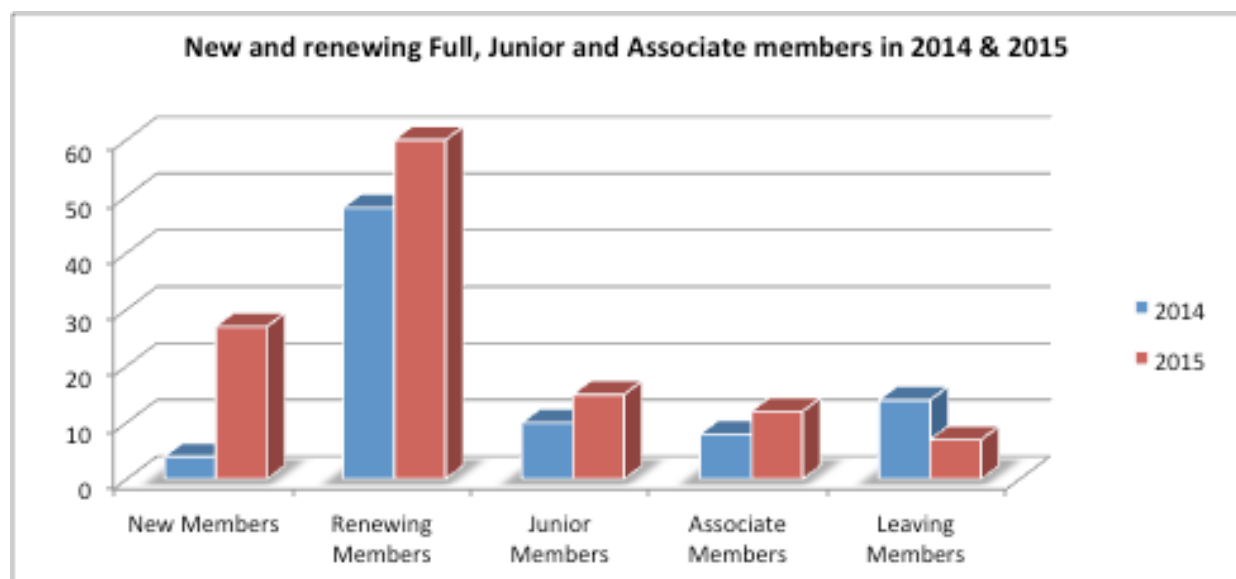
2.1 Numbers

ECSAC grew to a total of 89 members in 2015, this includes juniors, snorkelers and social members, the breakdown of these into the various categories we have is as follows:

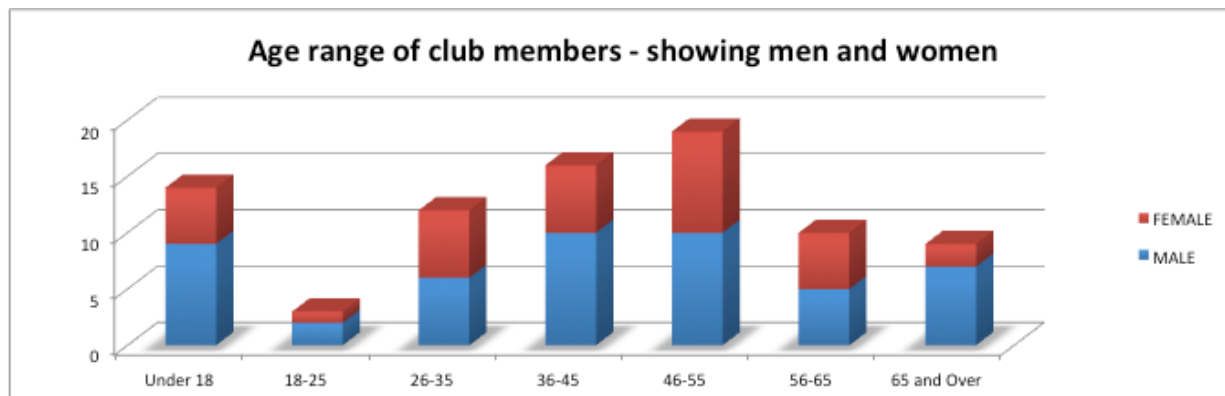


Our renewal rate for 2015 was 93% and comparing 2014 and 2015 it is clear that we achieved a much higher renewal rate (2014 having a renewal rate of only 80%).

The graph below shows a comparison of new vs renewing members in 2014 and 2015.



The club has a good balance of men and women with 41% of the members being women and 59% being men. The average age of our club members is 43, although this is brought down slightly by the non-divers in our snorkelling section. If we exclude the non-divers in the club then the average age is 47.



Using information from BSAC HQ and observing the presentations at the BSAC Conference in 2015 it is apparent that BSAC Membership overall is presently on a downward trend. In 2015 BSAC membership overall was about 28,000 members¹, reducing year on year by about 500, continuing a trend of an annual reduction of around 2%. East Cheshire had seen a higher reduction over the preceding years. From 2012 to 2013 our membership fees income reduced by over 4%. From 2013 to 2014 we saw a dramatic reduction of over 25%. This brought the club close to crisis as projecting our ongoing standing costs showed that if membership continued to fall then the club would not be financially viable in the future particularly as we have annual maintenance costs for equipment and boats and charges to keep the clubhouse operational. By taking action in a number of areas we were able to turn this around.

2015 saw an increase in our branch membership from 70 at the start of the year² up to 89. This was from a low in 2013 of less than 60 members and was an overall increase in membership from 2014 of 27%. Compared to 2013 this was a total increase of 50%. This was driven largely by efforts to attract new members and trainees via try dives, promotional activity and to raise our profile in the diving community in general and to expand the appeal of the club to a wider range of divers (including already qualified divers) and to retain more of our existing membership by seeking to deliver more trips and a wider range of diving options that appealed to existing members.

We ran a programme of promotions and try dives and extended our use of social media and Youtube seeking to promote the facilities and friendliness of the club – for more details see section 2.6 Promotion: on page 31.

In addition to the promotional activities we ran to attract new members we also targeted previous members who had left the club and managed to get 3 of them to rejoin as we had started to provide more diving trips and activities that delivered what they were looking for from the club. See section 4.1.5 on page 58. We actively canvassed past

members and sought to understand why they had moved away; some had given up diving and some were simply not aware of what the club was now doing. We extended our communications (weekly club emails) to ex-members who expressed an interest and this enabled them to keep in touch with what we were doing and also encouraged them to re-join. This is ongoing.

7 people left the club during the year - 2 of these left the area, 1 lost his job, 1 was due to the arrival of a new baby, 1 gave up diving altogether and the other 2 decided that they could no longer justify the cost as they rarely dived. Viz at our nearest dive locations did not help this either.

2.2 Senior Members

38% of our members have been members of ECSAC for over 10 years.

An analysis of our members reveals that 63% of divers in the club are Sport Diver and above, 44% are Dive Leader and above.

We recognise that providing interesting and varied diving is key to retaining these divers in the club. In order to ensure that we got input from across the club we decided to conduct three surveys during the year, the first to establish the sort of diving that people would be interested in, the second to see what training people wanted and the third was a survey of all those who were qualified as dive managers in the club to find out what trips they were prepared to run and wanted to partake in. With all of this data we were able to plan a programme of trips and training that appealed to all of our members and ensure that the more experienced divers in the club were able to do the kind of diving (and other activities) they were interested in without being tied to supporting less experienced divers.

The surveys showed that although the more experienced divers were happy to provide some support (for training and easier diving with newly qualified divers) they also wanted the opportunity to do more challenging diving and also other activities outside of the normal dives. This led us to run a number of additional dive outings and to expand our diving into a number of more adventurous areas, including mixed gas diving, deeper air diving (down to 48m) as well as adding a number of new activities to "normal" dive weekends such as water skiing and wakeboarding for which we extended the club boat insurance and purchased a set of watersports equipment that is now available to the whole club.

We also included the experienced divers in survey dives for the platform project and ensured that they were invited to join our project diving, see section 4.1.7.11 on page 70 and sections 4.2 and 4.3 on page 77.

2.3 Snorkelling

Our Snorkelling group has been in existence for a number of years but was really pushed into overdrive with the involvement of Dave Grindrod and more recently Mike Vale who is a dedicated Snorkelling Instructor (Mike is not actually qualified to dive, he is a qualified snorkelling instructor and focuses solely on that for our club). We are very proud of our Snorkelling Section and see it as an integral and important part of the club, we have trained over 150 snorkelers over the last few years with ages ranging from 6 to 75. ECSAC got recognition of its great snorkelling section from BSAC HQ as ECSAC were lucky enough to win the award for "Snorkelling Branch of the Year" in 2012.

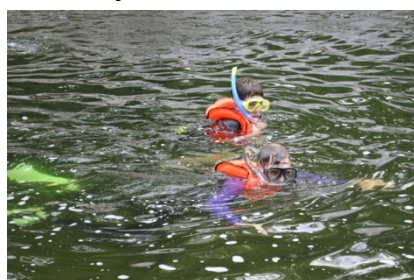
Mike Vale – Club Safeguarding Officer, Snorkel Instructor.



I have been a keen snorkeler since my childhood in Cornwall and later on the east coast of Scotland.

My first contact with the club was in early 2009 ahead of a planned family holiday to Greece later that summer. I had 2 boys aged 9 and 12 at the time, both strong

swimmers, but I was aware I was self-taught and very keen that they should learn to snorkel properly. I think I offered to



help our instructor, Dave, one week and before I knew it we had all joined the club. I found I really enjoyed instructing families and groups of cubs and scouts, and I became a snorkelling instructor in early 2010.

I formed strong friendships with Dave and other members of the club. Together with Dave and others, the snorkelling section of the club has been very successful over recent years training scout groups - we have built up contacts

with a number of groups who return every 2 or 3 years, attracting snorkelling members not just children of club members, organising snorkelling trips to Anglesey, the Lakes, even Salford Quays! (which is far more fascinating that you'd think - clear water full of fish life especially where they oxygenate the water). In 2012 we won the BSAC Snorkelling Branch of the Year. For details of that see page 19.



Both my sons progressed through snorkelling qualifications and my youngest Alex has recently completed his Ocean Diver qualification and is progressing to Sports Diver (and Triple Decker Capernwray burgers!)

When I was in my teens I had wanted to join a diving club on the east coast of Scotland, but at that time (or for that club) diving membership was not permitted until 16, although I did attend some trips in a non-diving capacity the opportunity passed. So I have always yearned to learn to dive but each year snorkelling commitments and instructing have kept me busy, perhaps this year....

East Cheshire have a great group of instructors so the opportunity is there for me to get qualified and join my son and dive on some of the club trips in 2016.



Dave Grindrod OWI and Snorkel Instructor.



I have always had an interest in snorkelling from being young and always hoped that the next holiday would be set along a rocky coastline. Most of our holidays were along the North Wales coast and Anglesey. The main reason for running the courses is to offer the same opportunity to youngsters who might not otherwise get the chance.

I am an Advanced Diver and Open Water Instructor as I have been diving since 1996. I also trained and became an Open Water

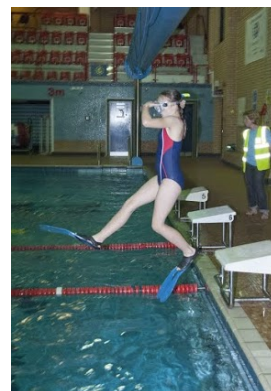
Snorkelling Instructor in 2005.

I moved to Hazel Grove in 2008 and looked for a club closer to my new home and joined ECSAC the same year. There had been a snorkelling group at the club in the past but with nobody running it at that time I took on the role of generating some renewed interest. Following an initial basic snorkel diver course with Chelford Scouts in 2008 we have had a stream of Scout groups coming to the club ever since based on word of mouth recommendation from one group to another and now regularly host both Scouts, Sea Cadets, Sea Scouts and Girl Guides within the club. Our most recent courses were run for Hazel Grove Sea Scouts and saw 12 Scouts complete the course and take part in a specially arranged Try-Dive session at the end of the course. Even going an underwater investiture with representation from their regional scouting team!



2.3.1 Pool Sessions

We run our pool sessions weekly alongside the scuba training in the pool on a Thursday night. This gives us the ability to share pool marshals to a degree and also aids us integrating the snorkelling section into the scuba training activity.



We are allocated half of the pool as we usually have a large number of snorkelers in the water, this also allows us to setup underwater obstacles and games and use the three meter deep end as well.

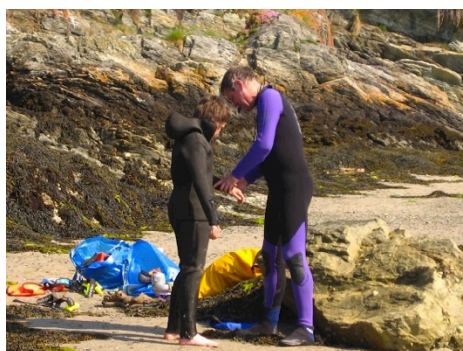
2.3.2 Developing Open Water Snorkelling.

Open water training and snorkel dives had been conducted in those areas generally used for scuba shore diving. Our Snorkelling Group have been to Capernwray snorkelling on the 6m to 8m platforms. We have received some interesting looks from scuba trainees wondering why they need all that kit if it can be done with a snorkel and also some compliments from seasoned scuba instructors. Our own instructors often comment on how much more comfortable trainees are doing try dives in the pool if they have been through the basic snorkelling experience beforehand. Progression from feeding the trout in the shallows through to drills using the platforms and then depth progression to the top of the horses then down to the Orca are all-possible. Viz is usually very good particularly around the Orca and this area tends to be relatively diver free ! The only problem here is that there is no relaxation on the price for children or snorkelers.

Devil's Bridge on the River Lune close to Capernwray is a very good fresh water site, there is also a burger van and plenty of space for picnics on a nice day. The water depth varies from the shallows to 6m under the bridge where duck diving for "loot" can be very productive. Unfortunately the last mobile phone that I found had some water damage !! I have both scuba dived and snorkeled here and there is more to see snorkelling from the surface than scuba diving to the river bed.



Our sea dives mainly take place around the North Wales coast and Anglesey. Chris Holden's Underwater Guides to North Wales volumes 1 and 2 are an excellent source of information and we are working our way through his suggested snorkelling sites.



One such site is Ravenspoint Gulley which we have snorkeled on a number of occasions.

Ravenspoint Gulley



We try and mix snorkelling with other outdoor activities such as camping, hill walking and fishing so that there is always something to do if the weather is not in our favour. One of the main advantages of Anglesey is that you can always find a sheltered snorkel diving site and last year was no exception. We found a sheltered site off Penrhos beach for snorkelling in the morning and then did

some sea fishing in the afternoon, with Alex (one of Mike's sons) catching a sea bass which we had around a campfire tea (with one or two burgers to help it along!!). We have also snorkeled around the Ravenspoint Gully area many times and have managed to dive



on the boilers of the Bothilde Russ, dive 10.1 in Chris Holden's volume 1 North Wales guide as well.

Anita Sherwood's book "Top British Shore Dives" is also an excellent reference for some of the shallower venues and its identification guide at the back as is the new article in the SCUBA magazine "Torbet on the Tube".

Dave bought a 3m inflatable with a 9.8hp engine to give us some additional flexibility in where we can go snorkelling. Many of the better areas are hidden around headlands where a long snorkel swim would be needed to access these areas from a beach. More adventurous dives are also made possible by the fact that the club has two large RIBs which can offer backup if we go diving and snorkel in the same general location. We have also run specific snorkelling trips when the boats were dedicated to the snorkelling group. Many of the divers have caravans at Rhoscolyn which enables us to use that as a base.



We are also looking closer to home for venues where we can safely train in open water and a number of watersports centres have been approached. Our dive team have also now installed a scuba platform in Salford Quays so this venue is one that we can use in the future. We are also planning to use the inflatable as boat cover which will allow us to work on boat entry and exit skills etc before we take to less sheltered sites along the coast.

We play several of the games suggested in the BSAC snorkelling book and Mike Vale picked some up when he completed the Instructor course. We play underwater bingo and lifting weighted milk cartons by blowing into them under water to improve confidence. Once our trainees have completed the basic snorkel diver / experience snorkelling course we encourage them to play games during our pool sessions with equipment we have made. Mike has egg (ping pong ball) and spoons for racing and we let them play octopush once they have gained the basic skills.

One instructional aid rather than a game that I have developed is to tape a single bubble from bubble wrap to toy soldiers (divers) and then to weight them using blu tac. It is possible to make them neutrally buoyant so I have 2 transparent tanks one with tap water and the other I get them to pour in salt. They each have a diver and weight them to make them neutrally buoyant in one or other of the tanks then have to figure out what will happen if you swop them to the other tank. They can then see with their own eyes what is going to happen transferring from fresh to sea water and can gain an understanding of why they will become negatively buoyant with a wetsuit and weights on.

The club has now also created the position of Safeguarding Officer and having reviewed the safeguarding information provided with the new snorkelling resource material and the BuddyGuard scheme from BSAC we now have a safeguarding policy which helps us maintain a significant ratio of younger members in the club, both divers and snorkelers. This demonstrates our commitment to integrating the younger members of the club. It also helps us integrate young snorkelers and divers into the club training, trips and pool sessions. See the example safeguarding letter on page 136.



2.3.3 Recognition of our Snorkelling Group by BSAC.

In 2012 the club was awarded the accolade of "Snorkelling Branch of the Year" an accolade we are very proud of.



This also led to us being featured in Scuba Magazine.



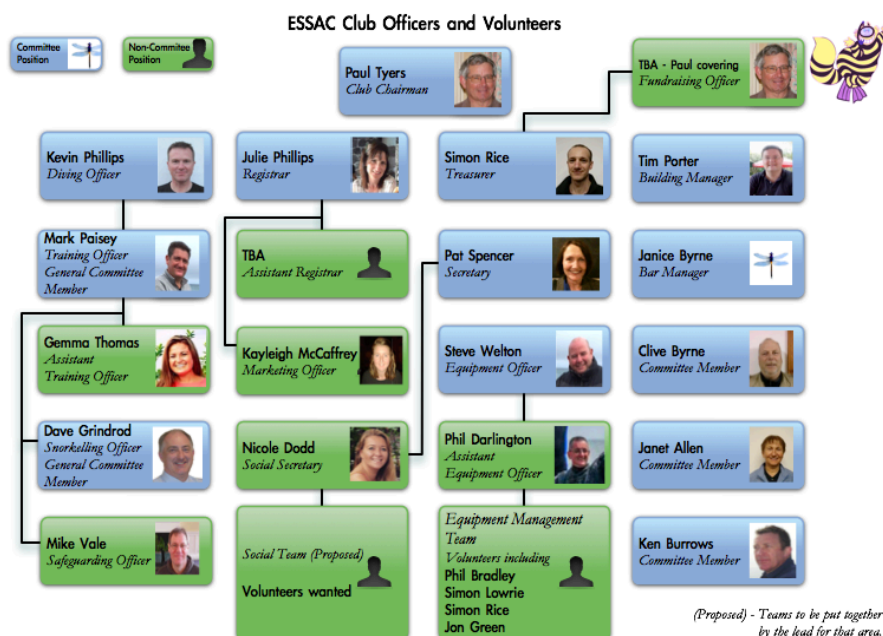

2.4 Administration

2.4.1 Branch Organisation and Committee

Our branch reconfigured its committee and volunteer structure in 2015 with a detailed new structure being approved by the committee. The new structure is set out in the diagram below - a larger version is available on page 125.



The club is a branch member of BSAC. The club constitution and rules adhere to those set out by BSAC.

We have a detailed Management Manual that sets out how the club works and this document can be found on page 118 in the Appendices.

As per the constitution the club assets and financial matters are managed by an elected committee. The committee consists of Chair, Vice, Treasurer, Secretary, Diving Officer, Equipment Officer, Building and Bar Managers plus 4 general members. (See our team structure at Appendix 7.2, on page 118.

Sub committees : DO liaises with Training and Assistant Training Officers

Equipment officer liaises with RIB and compressor teams as well as the equipment team who work on specific projects as they arise.

The Bar sub-committee helps with managing bar and functions.

Social Secretary helps to organise functions and fund raising events.

Buildings Manager co-opts willing volunteers for maintenance and cleaning of the clubhouse and we run working parties once a month.

Suggestion Box, and the weekly "What's on" newsletter as well as the all members email mailing list via Google groups involves all members. Asset register sets out all responsibilities and club rules.

The AGM adheres to BSAC constitutional rules. Held every year in March. For details of the Agenda and presentations given at the 2015 AGM see page 126.



2.4.2 Club Strategic Plan and Objectives

One of the keys to our success in 2015 has been a focus on organising the club in a way that ensures we direct our energies into the right things and ensuring we use our limited resources (money and people) to the best effect.

In 2015 we drafted our Club Strategic Plan, which identified the key objectives the club should be focused on and set out a long-term plan for their delivery.

At the highest level the strategic plan was formed of two parts. The immediate Mission and Objectives (intended to align to BSAC HQ's mission) and the longer term objectives.

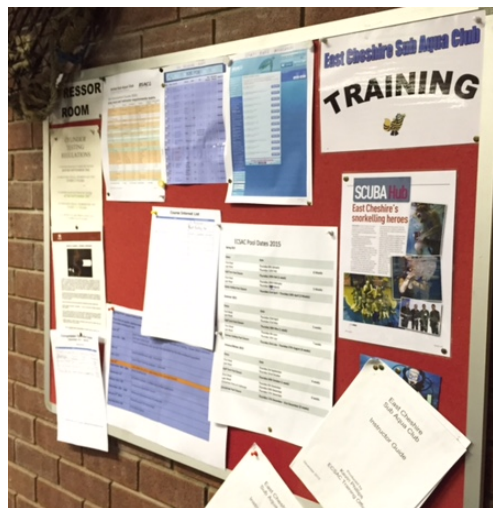

2.5 Information

2.5.1 Newsletters and Noticeboards

We maintain four noticeboards in our clubhouse, one for social events, one for training, one for trips and a further noticeboard for our snorkelling section.



In addition to these points of reference for members and visitors we also have verbal club announcements led by our Club Chairman on our weekly club nights so that those people who are in the clubhouse get to hear news straight from the horse's mouth and before it is sent out more widely via email and other methods.

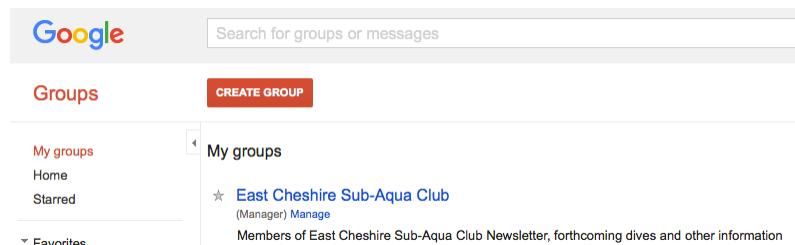
We also provide our members a weekly newsletter via email See section 7.13 on page 148, these are

comprehensive updates on all aspects of the club, from social events, dive plans, training, working parties, club nights, pool times and committee meetings etc. We also maintain a mailing list that enables club members to automatically email the entire membership if they have announcements or requests to make. This is accessed via Google Groups at

macc_scuba@googlegroups.com. This is a closed and moderated email mailing list which avoids spam finding its way to our members inboxes.



Over the year we average about 2 emails per week via the google group email list, it is used for a variety of purposes including trip announcements, selling dive kit, announcing social events and ensuring members are aware of key activities and news from around the club.



We also have a suggestion box in the clubhouse so that members can make requests anonymously if they wish – these are reviewed monthly by the committee.



We include our dive plans in our weekly newsletters as well as putting printed copies up on our noticeboard at the club. This is an example of one sent out in April 2015. It was maintained and reissued weekly throughout the year as new trips were added.

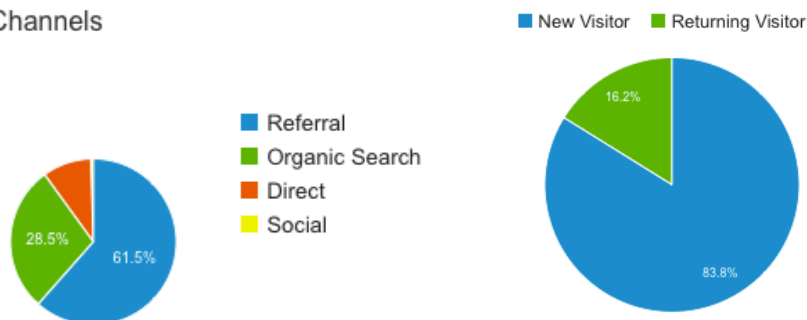

We are regular users of social media, using our twitter account and Facebook to push out details of social events and regular updates on our trips and activities.

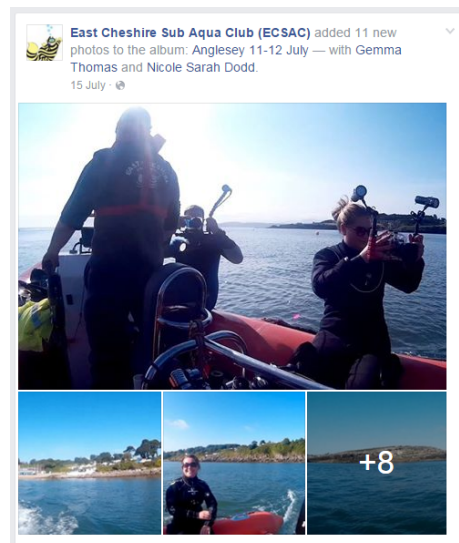

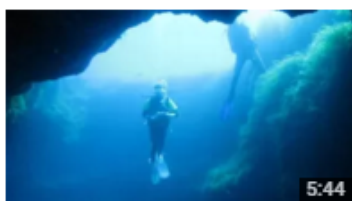

This is sent to new members directly after they join and a short introduction for each new member is included in the weekly newsletter along with a photograph of them so other members can recognise them at the club and events and are in a position to welcome them. Examples are provide below of both of these, as well as the full newsletters for 2015 in section 7.13 on page 148.

Kayleigh has produced a marketing plan that endeavors to make the most of the various channels available to us. This has a number of key elements which are covered in more detail in the earlier sections, but include: Newsletter: sent via email to past and present members as well as the current version being used in replies to all prospective members who contact us for details of the club. Website: our website is our main online presence with details of the club, trip reports, contact details and a members area where we store documents and reference material of use to the membership (dive logs etc).

We created an outline Marketing Plan as below:

2.6.2 Treacle Market.

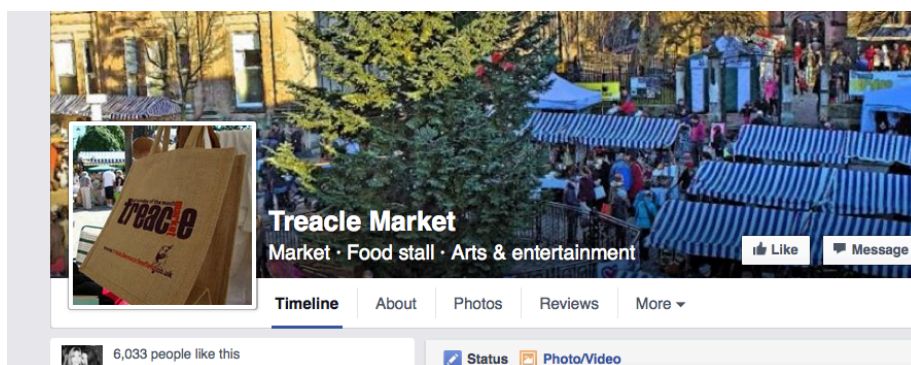
One of the local traditions in Macclesfield is the Treacle Market, this is a bustling Arts, Antiques, Crafts, Food and Drink Market, held on the cobbles of the historic Marketplace in Macclesfield, with around 140 stalls of food and drink, unique crafts and vintage finds, plus stalls and information from the Macclesfield community. We regularly attend the market and take a free stall (as a local community not for profit group). The organisers allow us to pitch a large stall in the Churchyard as below.

We use a members Gazebo and dress it with dive flags, BSAC banners and usually fill the stand with interesting dive equipment as well as a dummy wearing a drysuit as can be seen from the photo.



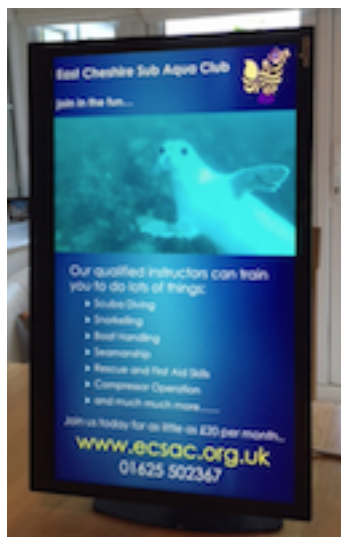
This is a great opportunity for the club to raise its profile and given the large number of people attending we are able to generate try-dives and awareness for the club, which of course is very local to Macclesfield.

In addition to the Market itself the Treacle Market also has a large following on social media with over 6,000 likes on Facebook. We are able to tap into this following and use their page as a means to reach the local population.



2.6.3 Club Promotional Kiosk

The club now has created a kiosk available for promoting the club. It is a standalone screen with a set of professional looking presentations and videos that runs automatically on a 26 minute loop and showcases UK diving in general our dive club and its facilities in particular and can be left running continuously without the need for any intervention. It is ideal for leaving at a reception desk at an office (or in a shop or used on a show stand). It will promote the club and encourages people to get in touch with us as it has both email, website and phone numbers on the screen at all times.

It has been used in a number of locations and most notably at a local employer to promote the club and to support the promotion of a Try Dive event. It is also used at club socials and other outreach events as a focal point, which draws people in and creates a discussion point. It is also designed to be left as a standalone unit and will act as a eye catcher and gives people contact details for the club so driving enquiries.

It also spent over a month at the reception of our local Leisure Centre and generated some enquiries for the club via email, which led to try-dives and potential members.



Our Local Leisure Centre



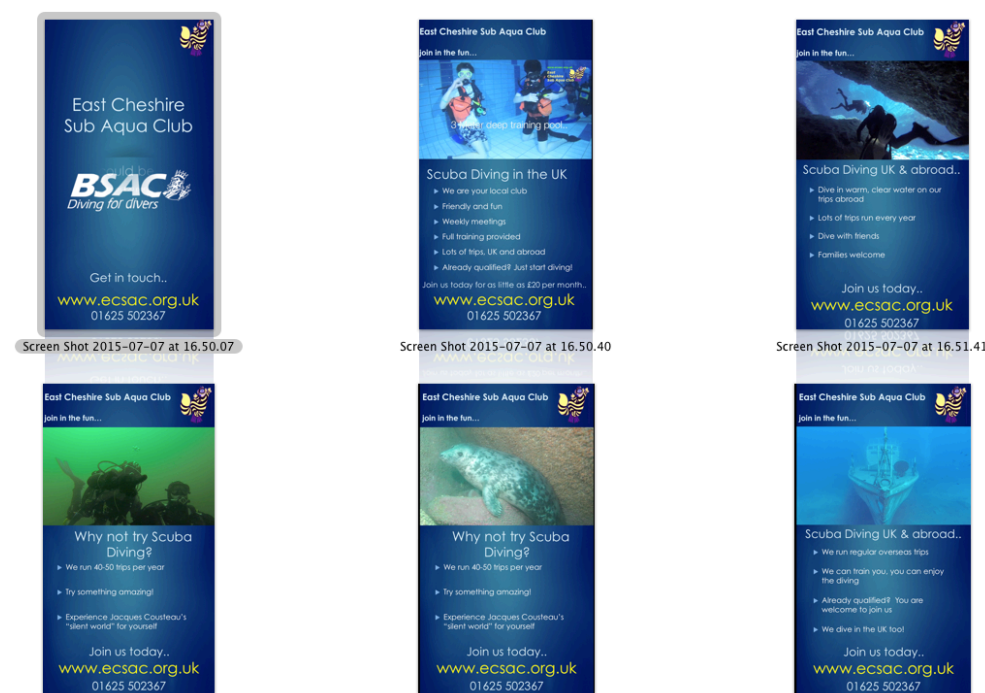
The extract below is from an overview taken from the leaflet we used to promote this with our members at the club. This was used during a consultation period with our members where we took input on the content of the Kiosk and also suggestions for places where we could use the Kiosk during the year.

The “kiosk” is designed to be a standalone screen left somewhere prominent (i.e. a reception desk in an office building, leisure center, sports club or on a stand or other high traffic area where people pass by). We have encouraged our members to give us suggestions and ideas as to suitable organisations we could approach to take the Kiosk while it is on tour. Ideally we arrange for it to be securely left at a variety of places for two weeks at a time and have it move around promoting the club. We also leave a set of club leaflets next to it so if people are interested they can take away a leaflet.

The Kiosk shows a set of screens with rolling video on a continuous loop, it will need no human intervention once switched on, just switch it on and it goes.

The concept is as follows:

The “kiosk” will be left at a place of work or club, Leisure Centre etc for a limited period (say 2 weeks). The idea is that the video will have a LOT of stuff flying around on it in the hope that some of it catches someone’s eye. It is also constantly changing and so over the period of two weeks while people walk past they see something different each day and we have a chance that some of it piques their interest. Each of the slides (with the static words on) stays on the screen for 3-6 minutes with the video running. The common element of each slide is the footer that says simply – join us for £20 per month – look at the website or ring us up. We also leave a set of leaflets next to the Kiosk so if people want to take something away they can do. Although the kiosk was a total of 26 minutes of different content we are not expecting anyone to stand and watch the whole 26 minutes of video.. Ideally any given five seconds during the full runtime of the videos should be enough for someone to get the message and have the info needed to get in touch. What we have tried to do is include some cool looking stuff (Seals, Dolphins, Boats, Divers etc) that may at least grab their attention as they walk past, if they are interested then they can get in touch.



The Kiosk will show a set of screens with rolling video on a continuous loop, it will need no human intervention, just switch it on and it goes. The screens look like the pictures on the left, the images are all videos that will run on a loop one after the other.



3 Diver training

3.1.1 Training Officer – Mark Paisey



Our training team is led by Mark Paisey, Advanced Instructor, First Class Diver and qualified RYA Instructor and Technical Diving Instructor. Mark is a former RAF Pilot and currently an Airline Pilot Instructor for British Airways and comes from a very structured

background which enables him to bring both a wealth of knowledge and a hugely professional approach to his work with the club.



My name is Mark Paisey and I am the current Training Officer. I started diving in 1982 at Hull University Sub Aqua Club. My diving continued as part of a Special Branch in the RAF based in Germany where I sat the original Club Instructor qualification and continued to Advanced Diver. Having moved to Rhiyadh, Saudi Arabia, in 1994 I continued diving with a BSAC branch which was part of British Aerospace, mostly in the Red Sea and swimming pools. Returning to the UK in 1997 I then had a 10 year break from diving until my son, Henry, reached 12. He became interested in learning to dive and started with the Sea Cadets at Neptune, Liverpool. To progress his diving I restarted and became a BSAC Direct member eventually joining ECSAC.

Since 2007 it's fair to say I became obsessive and progressed to FCD, AMGI and AI. For me helping others to share my passion and progress their skills is reward in itself.

My main aim is to deliver a training plan that meets the aspirations of all our members. We start with an annual request for personal development and build a training plan around this thus targeting our resources. We have an Assistant Training Officer, Gemma Thomas, who coordinates the pool training and Try Dives. Allocated instructors progress their trainee to the completion of open water training and a little beyond so they receive guidance on equipment purchase and the transition to boat diving within the club. Training to Sports diver and beyond falls under the annual training plan. We also run an extensive SDC programme ranging from the Buoyancy and Trim Workshop to open circuit mixed gas. Our dry courses are supported by



instructors from other branches e.g. the First Aid for Divers and AED courses, are delivered by Adam Rhodes, a paramedic, from Manchester University SAC. In turn some of our instructors help his club deliver Ocean diver training.

3.1.2 Assistant Training Officer



We have an Assistant Training Officer who is responsible for organising the pool training and delivery of Ocean Diver Training and Try Dives. Gemma Thomas.

Gemma Says... "Having been diving since my post university gap year, I have progressed from diving abroad to becoming an avid all year round UK diver, as well as teaching in the UK. My training started with PADI and I completed the BSAC crossover course with support from the instructors at ECSAC and the regional training team. I have gradually increased my knowledge of the BSAC diving curriculum, attending several events including this year's conference.

I am thoroughly enjoying the position of Assistant Training officer within ECSAC, being able to use my experience to make sure students and try divers get off to the best start with the club and with scuba diving. I aim to get to know what each new diver is looking to get out of the sport, whether they want to progress quickly or want to take their time. I enjoy seeing students progress and build their confidence or decide to become members following an excellent try dive experience. To be a part of such an excellent training team with so many talented instructors is something I'm very proud of, everyone has such different and varied qualities to bring.

I would like to further my own involvement at the club, potentially by taking on another committee role in the future, what I am doing now is a great stepping stone for this and a fantastic opportunity that ECSAC have provided."

3.1.3 The Training Team

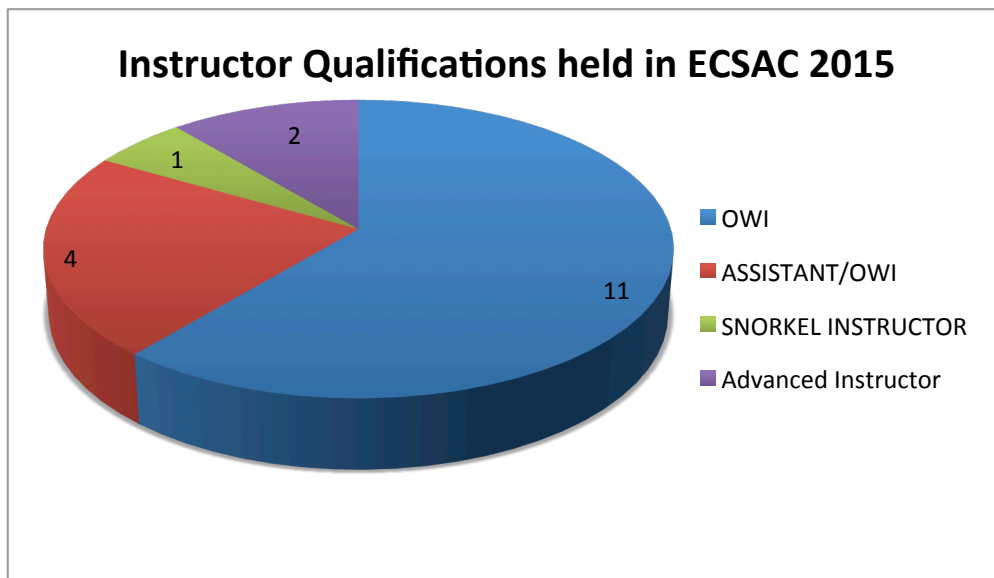


We have been very lucky in ECSAC to have a strong training team with two Advanced Instructors and 11 Open Water Instructors in the club. This was increased in 2015 by 4 with 2 new Open Water Instructors qualifying and a crossover instructor from PADI as well as a new Assistant Instructor.



3.1.4 Instructor Qualifications 2015

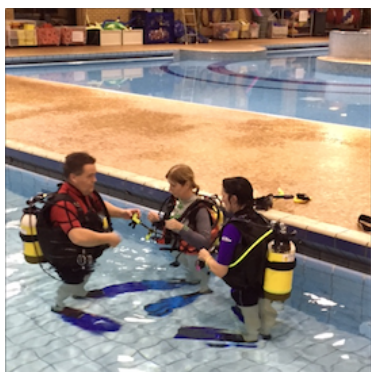
During 2015 we qualified an additional Assistant Instructor and two more Open Water Instructors, we were also lucky to attract new members who were already qualified, one being an PADI Open Water Instructor – who crossed over via an BSAC OWIC course and an already qualified BSAC Assistant Instructor.



3.2 Water-work

3.2.1 Pool Training

East Cheshire SAC has the use of Macclesfield Leisure Centre pool every Thursday night from 20:00-21:00 outside of school holidays.



The main pool is 25m long and has a max depth of 3m. Normally the pool is divided in two to facilitate diver and snorkel training at the same time. The pool costs £97 per session and fees of £4 are collected from each user to meet the cost. Try dives are charged £15 which also contributes to the pool fee throughout the year. During 2015 we reduced our pool



bookings, dropping school holiday nights (which had traditionally been very low usage) in an effort to break even on costs. In past years we have regularly lost up to £2,000 when comparing pool costs to income. In 2015 our pool costs reduced to £3,500 (from £5,000 when we stayed open in school holidays) and income was £2,500. This substantially reduced our overall costs for pool usage and reduced the overall cost burden on the club without impacting our ability to deliver training.



3.2.3 Try Dives

ECSAC promotes itself through Try Dives throughout the year offering these as a taster of the sport in an effort to encourage people to join the club and train with us. We also put together a special Christmas package that includes a try dive and a tour of our clubhouse and facilities as well as a free drink at our bar. We usually sell this in the run-up to Christmas as a simple stocking filler and package it with the BSAC Try-Dive booklet and a special voucher that can be redeemed against the try dive on a date that suits the recipient.

Participants in our Try-Dives come from recommendation, advertising initiatives e.g. Macclesfield Treacle Market, local Scout groups, club website and local press stories.

We use BSAC promotional material and the Try Dive packs. Participants are emailed with the details of where and when and asked to bring T-shirt and swimming costume. We supply remainder of gear from club stocks. Try Dives are charged at £15 which contributes to our pool costs. Snorkelling members get a free Try Dive as part of their course to encourage progression.

Our last mass Try Dive event, organised by our Assistant Training Officer Gemma , targeted members of McCann Ericksson a local business. To allow the 15 attendees time in the water a conveyor system was used with briefings, kitting up, water time, dekitting and debriefing being conducted by different instructors. The recent change allowing use of Dive Leaders for Try Dives has freed up resources for these events and allowed us to increase our capacity for try dives.

All Try Divers are given a BSAC pack and invited back to the club for a tour and information on expected membership and training costs and training timescales. Many join there and then so forms are completed and a photo taken which we then use to include a welcome to the club section in the club newsletter. The use of the BSAC Direct Debit system has also improved our sign up rate due to reduced up front costs which in the past had been potentially prohibitive for some prospective members. The whole club is migrating to this system, which we hope will also assist with retention. We use a group email system so new members can immediately access 'Whats On' information. Their photo is sent around so everyone knows who they are and can make them feel welcome at the clubhouse.

3.3 Theory lessons:

Theory lessons for Ocean Divers are normally run at the clubhouse on Thursday evenings in our purpose built lecture room on non-pool nights. Sports Diver lessons are normally packaged into groups and delivered integrally with their course. Dive Leader and Advanced lessons are delivered when required. We encourage Sports Diver attendance of the Oxygen Administration and Practical Rescue Management SDCs so many of the Dive Leader lessons will already have been completed by the time the course starts. This year 2 members, Gemma and Dafydd Thomas, made use of Regional training to complete their Advanced lessons in a weekend whilst our current candidate, Roger Tomlins, has chosen to progress his lessons on club nights.

The training room is well equipped with projector, whiteboard and flip charts as well as a 70 inch high definition TV that is used for training videos and theory presentations. Multiple training aids are available for use including resuscitation dolls, AED, and a variety of equipment that can be used for demonstrations.



3.3.1 Ocean Diver Training

This level is normally started in October and carries through the Winter into Easter time utilising the pool fully. The long time period allows for consolidated training and completion of all lectures and the theory exam when trainees are ready. As trainees normally carry out their training with the same instructor the club runs a skills assessment session with a different instructor for quality control. This is normally conducted with hoods and gloves as a transition session to open water. The trainee then receives drysuit training in the pool before moving to the local quarries at Ecclestone Delph or Capernwray. We normally complete their open water training over a weekend which allows progression to boat diving from Anglesey.

3.3.2 Sports Diver Training

This level commences as required but normally twice a year around Easter and October. Recently the club has benefitted from an influx of PADI cross over members and to encourage them intensive long weekends away have been used to introduce UK diving from RHIBs. Fred Santos and Nicole Dodd attended a long weekend in Cornwall 18-20 September in 25m viz to complete their open water lessons. This has proved a very successful vehicle but equally we support long term Sports Diver training as illustrated by Sue Wainwright who has taken 6 years to complete her training through personal choice!

3.3.3 Dive Leader Training

This level normally commences in October with completion of the Oxygen and Practical Rescue Management SDCs. Once the other lectures are completed the open water lessons are completed through an intensive weekend. Members have used Regional events for this purpose or to complete missing lessons eg Wilf Wooldridge. The idea for skills weekends came from instructor participation in Wales Region training events and had proved successful. Our next Dive Leader candidate, Andy Bickerdyke, is on this programme currently and will complete his course by December.

3.3.4 Advanced Diver Training

The club has certified one member in 2015, Steve Welton, who completed his 2 day weekend in the Lley in June. Members are offered in house training or can use Regional events. Gemma and Dafydd Thomas completed their lectures Regionally whilst Roger Tomlins has chosen to complete them in house. Again an advanced skills weekend will be programmed and support given for expedition planning.

3.3.5 FCD Training

The club has had one successful member in 2015 and this has encouraged 2 members, Kevin Phillips and Mark Hickson, to progress with this level in 2016. These members will use the Northwest Prep group for guidance under Sean McKenna and Maria Harwood. The Prep group is coordinated by Mark Paisey from ECSAC.



3.3.6 Skill Development Courses

ECSAC is very active running SDCs and offers all its courses and facilities to the Northwest Region. We have been successful in attracting BSAC Direct members into joining our branch as a consequence of their experience on these courses. They join as out of port members with a reduced membership fee enabling them to participate fully but with a fee structure that reflects their likely reduced attendance.

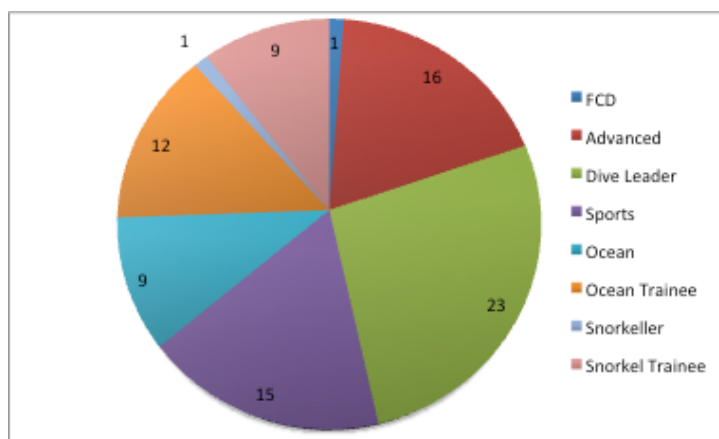


3.4 Qualifications

We have managed to qualify at least one diver into every BSAC diver grade during 2015.

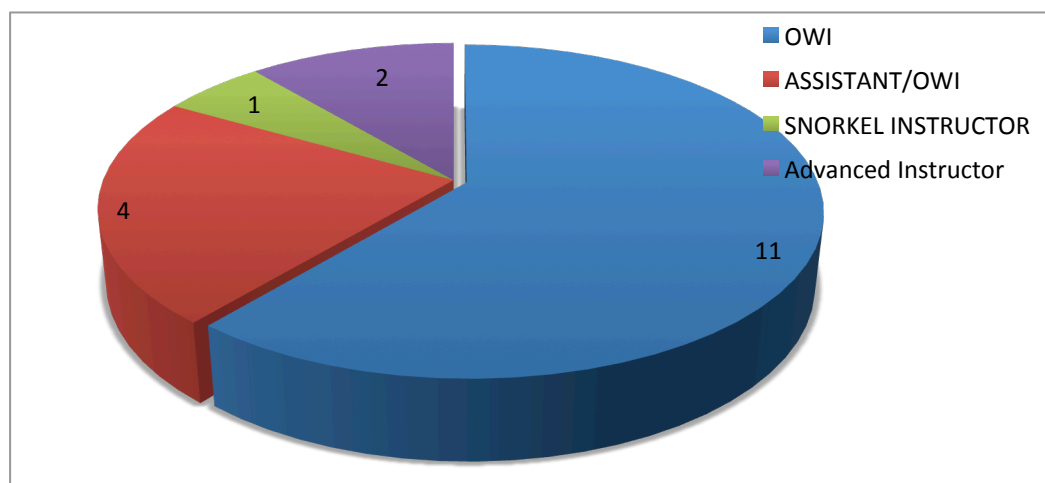
By focusing on what our members want to pursue and encouraging progression and providing lots of opportunities for people to develop new skills we delivered over 20 SDCs in the course of 2015.

3.4.2 Instructor Qualifications as at end 2015



During 2015 ECSAC gained one Advanced Instructor from a combined event in 2014, Mark Paisey, who has been awarded the Analox Award at 2015 BSAC Conference for "Most Meritorious Performance in the AI Exams".



Gemma Thomas gained her OWI status as a PADI Cross Over Instructor having attended an OWIC in May 2015. Clive Byrne and Tim Porter passed their PIE on 10th October. These members benefited from an arranged Regional instructor development session with Mike Holdroyd prior to their OWIC. Wilf Wooldridge attended an IFC having completed Dive Leader training in October.

As part of on-going instructor development we held three instructor meetings in the year to canvas instructors input on our training programme and feedback what development they wanted for themselves.



As part of the feedback from the instructor meetings we identified that our instructors wanted us to run a workshop covering key areas of the DTP and give the opportunity to practice lesson delivery as well as compare notes with the regional coaching team on how best to deliver the DTP.

This workshop was held on 29th November at Ecclestone Delph with input from our regional BSAC coaching team. 7 instructors attended the workshop led by Maria Harwood (NW Regional Coach) and Mike Holroyd Instructor Trainer from outside the club aimed at a fun day to refresh teaching skills.





We ran the Instructor Workshop at Ecclestone Delph with the help of our BSAC regional coaching team Maria Harwood and Mike Holroyd. This was a great opportunity for ECSAC to develop our already enviable instructor team. A great day was had by all and despite

the chilly weather we managed to run through a lot of training scenarios and create a real buzz within the team. Our focus was on rescue scenarios and ensuring we have a consistent and effective training approach to rescue skills. This will be utilised in the new year when we plan to run a rescue refresher for all members at the pool to ensure we are all ready for the new season and proficient in rescue and incident management skills. We will also be running the Lifesaver and Advanced Lifesaver SDCs on 5th/6th March 2016 2016.

In addition to the workshop we also employed some new technology to capture examples of “demonstration level skills”, these were captured via video and provide a reference for the instructor team to use as the baseline for skills taught as part of the DTP. This allowed us to ensure we delivered consistent training and also provided a resource that can be used with students to show them the skills they will be taught as part of their training. These are now used as part of the theory lessons and allows a visual “preview” to be provided to students as a further extension to the instructor’s REAP debriefs.

We created videos for each of the following skills:

- Kit Assembly
- Buddy Check
- Giant Stride entry
- Controlled Descent (in buddy pairs)
- Controlled Ascent and surfacing (in buddy pairs)
- Basic Buoyancy skills (fin pivots)
- Mask Clearing
- Regulator Clearing & Regulator
- Use of an Alternative Supply
- Controlled Buoyant Lift
- AS Ascent and surfacing procedure (building on deployment)
- CBL - Ascent and surfacing procedure



We aim to work with BSAC HQ and assist if possible in their planned skills videos as we are aware that the National DO is considering these.

3.5 Equipment:

3.5.1 Equipment Officer – Steve Welton.



We have a team of people engaged with the management of the club Equipment, led by our Equipment Officer Steve Welton. An engineer by trade, Steve is very well organised and superbly qualified to look after these key club assets. Steve is supported by a team from around the club who are

able to provide support for both the management and maintenance of the club equipment as well as supporting the various projects we run through the year, including such things as fitting a new A-Frame to the boat as well as building and installing a training platform in Salford Quays – see section 6.1 on page 98.

My name is Steve Welton and I have recently taken over the role of equipment officer within our BSAC Branch. I started scuba diving in 2004 with another agency and have continued to add additional skill sets by formal training and going diving with other more experienced people. Since crossing over to BSAC I have continued on the skill development route which I greatly enjoy and adds different dynamics to just diving. I have successfully completed Diver Coxswain, Compressor Operator and gas blender amongst others. My proudest achievement under BSAC to date has been to gain my Advance Diver certification, which was hard earned. I still dive all year round in the UK and abroad and really enjoy the sport. It's a shame work gets in the way.

The role of equipment officer is fulfilling and challenging at times. Taking on this role felt like the right time to give a bit more back to the club. Many of the roles within the club do rotate within the members to keep fresh ideas and enthusiasm at a consistently high level. We are very fortunate to have such an abundance of equipment at our disposal. The equipment has been purchased and maintained over the years by the efforts of the club members. 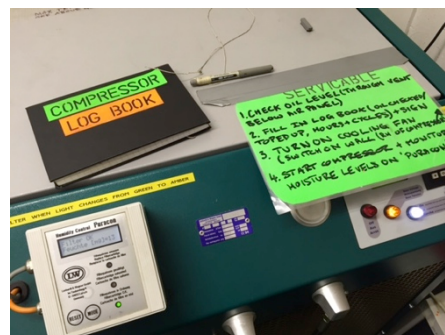
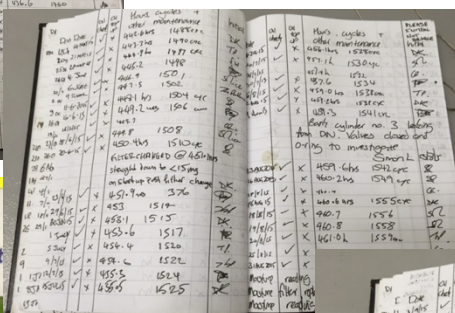
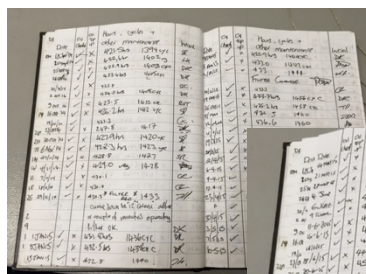


3.5.2 Compressor Station

Here at East Cheshire we have access to a Lenhardt & Wagner LW 450 E air compressor which is capable of 300 bar air fills. This is backed up with 6 x 42 litre 300 Bar cylinder air bank and 2 x 75 litre 280 Bar cylinder air bank. On average the compressor runs for 50 hours a year providing around 27000 litres of air in any given year. An added bonus to the air bank and compressor is the capability to provide nitrox and trimix fills via the gas-blending panel.



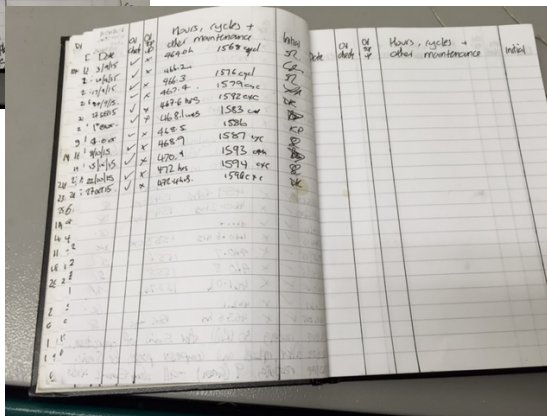
The use of the compressor is logged to ensure that operators follow the correct start-up process and we are able to track who uses it and how many hours the compressor gets used for. This enables us to manage the maintenance schedule and monitor usage.

The logs show the compressor ran for a total of 41 hours in 2015. The compressor went through 160 start cycles in the year showing how well used the compressor is. It usually runs every week on a Thursday and often does special runs in advance of club trips. We estimate that well over 1,500 cylinder fills were done during the year (we do on average 10 fills a week just for our pool training sessions). This provides a benefit to our members of over £5,000 compared to commercial air fill prices, on average a benefit for £60 for each of our members.



3.5.3 Gas Blending Panel



The gas blends are calculated utilising a computer program on our dedicated compressor room PC with the backup of standard tables. Standard air fills up to 300 bar are offered to club members at no extra cost but most members offer a small donation in order to support the maintenance requirements of the air station.

Nitrox and Trimix fills are offered via 4 x 97 kg O₂ cylinders and 2 x 67 kg Helium cylinders. These fills are offered at cost price, which is a great advantage to club members. Nitrox and Trimix analysers are available to

test the blends on completion and cylinders marked up as appropriate % of gas blend and MOD.

With such a great facility we have also been able to offer SDC's on compressor operation and gas blending to our members and other BSAC clubs in our region.

3.5.4 Dive Boats



One of the main attractions for me originally joining the club was the access to not one, but two diving ribs. Top Cat & Cheshire Cat. Both boats have generally been stored in the boathouse pictured above and towed to the dive sites with members' own vehicles or the club minibus. As mentioned above fresh ideas are at the core of a successful club and the committee received a proposal to store one of the ribs (Topcat) on the isle of Anglesey for the 2015 diving season. See 7.10 on page 140. This proved to be very cost affective as predicted in the proposal due to the rise in fuel costs associated with towing boats to North Wales and back to Macclesfield each weekend. This is also expected to give a return to the club funds which can be used for service and maintenance.



3.5.4.1 TopCat

Top Cat is a 5.85m rib with a single 140hp 4 stroke Suzuki outboard engine manufactured by Ribcraft. The Rib is equipped with a vhf radio, Lowrance HDS 5 depth sounder and plotter.



This Rib was originally provided by Ribcraft to support the water sports events during the 2012 London Olympics. Once the Olympics were over the boats were offered for sale at a greatly reduced cost and ECSAC club purchased one of the boats. This acquisition was not only great value but has enabled a great deal more diving to take place. As part of continual improvements we raised funds enable us to purchase an A-Frame for this boat this was done to enable the fitting of navigation lights, a higher radar reflector and also increase the range of the radio and thus enhance the safety of our boat use which supports the clubs expansion of diving to deeper sites further offshore.

3.5.4.2 Cheshire Cat

Cheshire Cat is a 5.5m rib with twin 70hp 2 stroke Yamaha outboard engines manufactured by delta powerboats. The Rib is equipped with a vhf radio, Lowrance depth sounder, gps and plotter. This rib is showing its age and use a little now and we have plans in place to submit a grant application for converting to a single 4 stroke engine.



We have fitted this boat with a new radio that provides an AIS function. The Automatic Identification System (AIS) is an automatic tracking system used on ships for identifying and locating vessels by electronically exchanging data with other nearby ships and AIS base stations. It is also used for Man Overboard (MOB) emergency situations and enables location of crew members and divers on the surface of the water if activated. A number of our club divers use AIS Personal Locator Beacons and this facility enables us to locate divers on the surface if they are separated from the boat for any reason. Once a diver's beacon is activated, the AIS receiver in the radio will alert the Cox and provide distance and bearing to any activated beacon within a 5 mile radius. It also interacts with other AIS enabled vessels and provides collision avoidance alerts to the Cox which is a useful benefit in some of the high traffic areas we occasionally dive around Holyhead etc.

This rib is now showing its age; we have plans in place to raise money for converting to a single 4-stroke engine which will lower the maintenance overhead and the running costs. This will be undertaken in 2016.



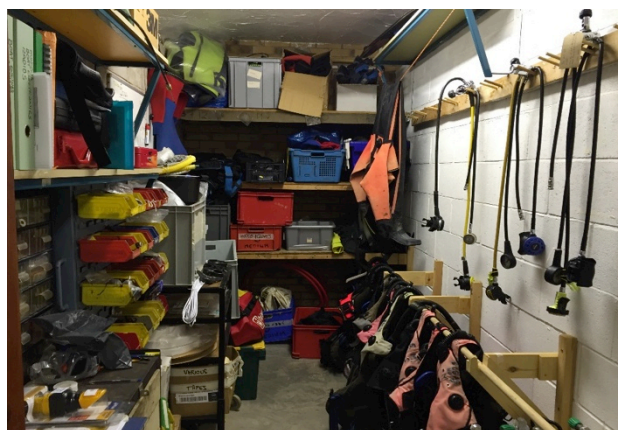
3.5.5 Minibus

Our club minibus enables us to tow one of the ribs and carry a large amount of equipment for a diving trip. The minibus is often utilised for taking groups of divers to open water for training purposes and the weekly pool session at the local leisure centre as well as transporting kit for scouts and groups try-dives. This facility enables members to travel together to help form stronger personal bonds with each other and cutting down on travelling expenses.



3.5.6 Scuba & Snorkelling equipment

The club scuba kit comprises of 12 x full sets of kit. All the items have been numbered in order to keep track of the individual pieces of equipment maintenance requirements. The BCD's are generally Buddy Commandos which have been a stalwart of BSAC over the years. They are both hard wearing and easy to maintain. The regulators are Apex DST which are robust in construction and provide a good consistent breathe.

We have a large selection of fins and masks which have been purchased or donated to the club over the years. Any scuba equipment issued is booked out and back in again on return, via a simple T-card tracking system. The simplicity of the system means that anyone can easily establish who has been issued with what item of equipment.



Two Luxfer O2 kits are always on hand when we are carrying out any diving activities. Robust carry cases have been manufactured by club members to protect the O2 kits from damage and also water proof them when being used on the diving ribs.



Also available for loan are:-

3 x 7 litre cylinders, 1 x 10 litre cylinder and 3 x 12 litre cylinders. 4 x Buddy Commando BCD's, 3 x Buddy Slimline BCD's and 2 x Seaquest BCD's, Various weight belts, Dsmb's and lift bags.

ECSAC won the snorkelling branch of the year in 2012 and received 5 x sets



of snorkelling equipment as part of the award (see page 19). The kits consisted of:-

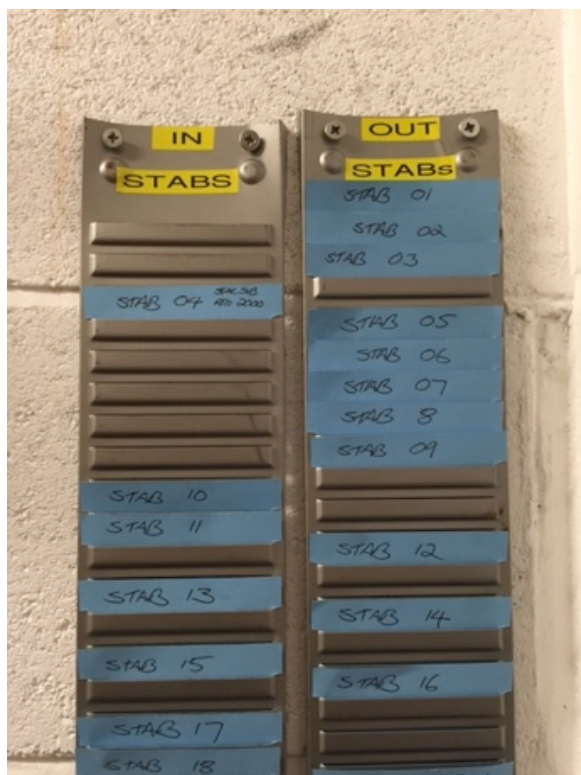
5 x Masks, 5 x snorkels, 5 x pairs of fins (various sizes) and 5 x wetsuits.

Together with numerous other items of snorkelling equipment they have been put to great use over the last few years with our very busy snorkelling section led by Dave Grindrod. More on that on page 14.

Maintenance on the equipment is generally carried out by club members who between them have a wealth of knowledge and experience in all aspects of mechanical and electrical maintenance. We are also very fortunate to have club members who are qualified in air compressor and diving regulator maintenance. Any specialist maintenance & testing such as cylinder or J bottle testing is outsourced to local suppliers. Regular working parties are organised throughout the year to carry out maintenance of the clubhouse and surrounding grounds and we actively encourage existing and new members to get involved. Maintenance records are kept in paper format and online in a drop box account so they can be viewed by all committee members.

We maintain logs of equipment issue via a T-Card system that enables us to track when equipment is issued and who currently has it.

As can be seen from the photos on the right and below the system is simple and easy to manage and enables the equipment team to quickly see what kit is available to loan at any one time. At the time this particular photo was taken you can see that a large amount of kit is out on loan (the right hand column is the "kit out").



As part of our training programme we provide kit to trainees free of charge; a refundable deposit of £100 is taken which is then returned to trainees at the end of their training when the kit is returned in a reasonable condition. We maintain the kit for them and will conduct appropriate servicing and repairs free of charge. We would only use (or retain) the deposit if equipment is lost or damaged outside of "normal" wear and tear.



3.5.7 Clubhouse

We are lucky to have a purpose built clubhouse, designed specifically for the dive club and funded and built by the members themselves back in 1991.

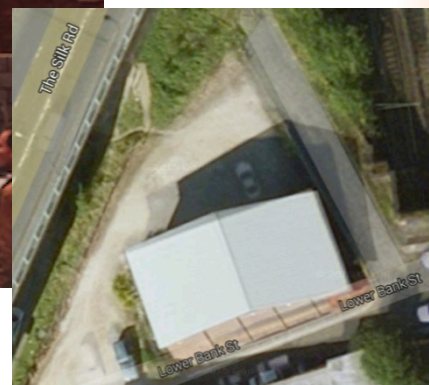
This gives us boat and equipment storage, compressor, bar and function room as well as training facilities.



The clubhouse was designed by the members, for the members. Planning permission was obtained for the clubhouse in January 1991 and was built largely with the efforts of members themselves taking part in the construction as well as a number of specialist contractors being employed for those elements that required specific skills.



The first brick was laid in September 1991, the final one in September the same year with the roof and fitting out commencing soon after. In all the building cost £110,000 to construct – average property price changes in the intervening period would suggest that this would be nearer £250,000 today.



Training



3.5.7.1 Working Parties

We regularly arrange working parties to attend to maintenance of the clubhouse, boats minibus and surrounding area. We ran several of these over the course of the year in 2015. We usually have a team of enthusiastic volunteers turn out for the working parties, lots of work gets done as there is always stuff to do at the club. We managed to get lots done during 2015 with boat, trailer and minibus maintenance, outside areas, landscaping and car park as well as maintenance of a number of other areas inside the club including the fire alarm, bar, stock room, lecture room and kitchen.

4 Diving activities

4.1.1 Diving Officer – Kevin Phillips



Kevin first joined BSAC in 1978, then with Hartford Sub Aqua Club and enjoyed many happy family holidays with his father, uncle and cousins all of whom were avid divers at the time. He stopped diving when he moved away from home with work, got married and had a young family, when the opportunity arose to restart diving with his daughter he took up the sport again with enthusiasm and he and his daughter were re-qualified in 2009.

Kevin then progressed to become a PADI Divemaster, qualified Cave Diver and joined ECSAC in 2011, taking a general role on the committee, qualifying as a BSAC Advanced Diver, Open Water Instructor in 2012 then progressing to Assistant Training Officer, Training Officer and then Diving Officer in 2015.

"I joined ECSAC as I wanted to benefit from the more social side of diving and progress from holiday diving into a wider range of diving offered by the club structure. I must admit to wanting to recapture some of the adventure I felt as a boy diving with BSAC and this has been one of the great joys of joining ECSAC and getting to do some fantastic diving with a great group of people".



4.1.2 Branch dives

All club dives are logged on our own log sheets and these records kept on file in the club for reference if required. See example on the right and full size version at in section on page 140.

During the year we undertook over 1,000 club dives (that being dives organised as inclusive trips open to all our members). In previous years we had seen a gradual reduction in the number of dives run by the club and also a significant reduction in the number of people actually diving. This was trending with the reducing membership and demonstrated a loss of enthusiasm within the membership. During 2015 we endeavored to drive up the amount of diving done within the club by identifying what kind of diving the members wanted to do and then running more of these kinds of trips. This injected some variety into the club's diving and also introduced new

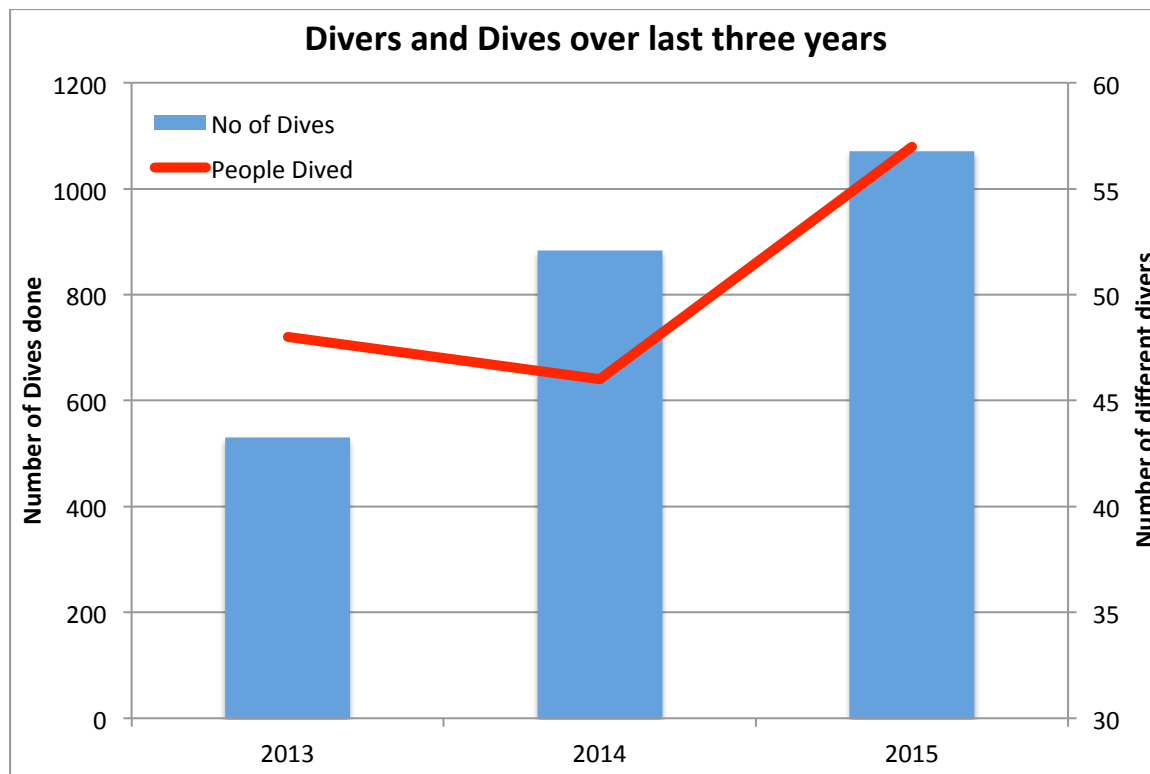

types of dive site which led to many more people diving in 2015 than had been the case in previous years.

An analysis of the dive logs from 2013, 2014 and 2015 demonstrates the significant change in numbers and also shows that we managed to avert the downward trend.



As part of our push to increase the volume of diving we also introduced “Target 1000....” which was an initiative that regularly reported the number of dives completed and enabled us to celebrate the 1000th club dive immediately after it happened while on a club trip to the Sound of Mull in late September.



This was worthy of a celebration, having hit the milestone of 1,000 club dives in 2015. Our group diving up in Mull completed the 1,000th club dive of 2015 whilst diving on the wreck of the Hispania – the

whole boat celebrated with a bottle of bubbly (drunk very responsibly whilst on a diving trip of course)...

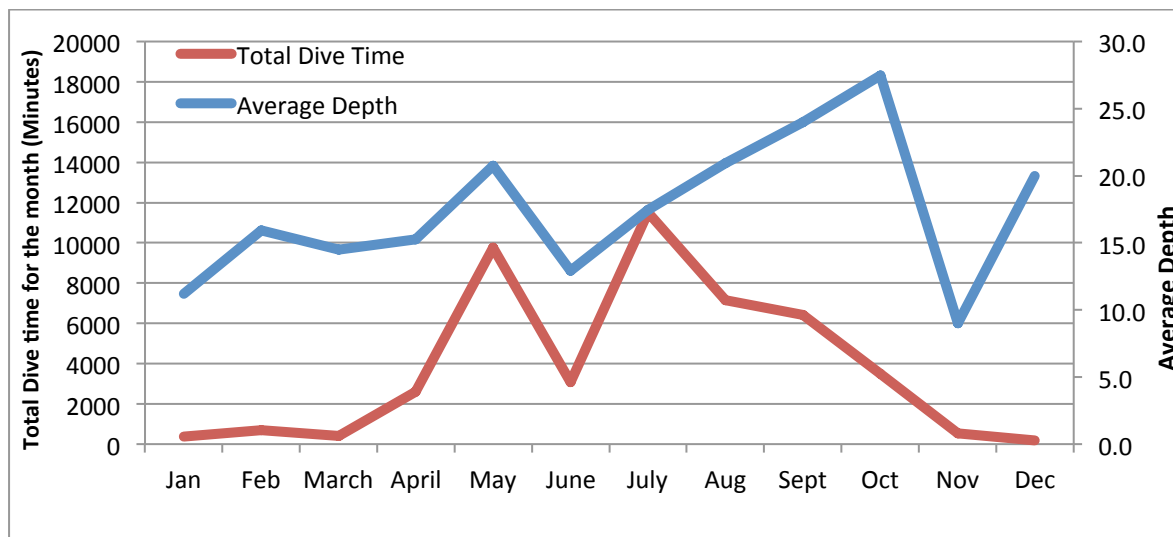


The Mull Dive team celebrating the 1,000th ECSAC dive of 2015..!

Our approach to diving through the year is to build up progressively as can be seen from the extract from our dive logs below that shows how we gradually built up depth as the



year progressed. We arranged early season warm up dives and ensured that these were sites suitable for less experienced people and enabled those divers who usually lay off during winter to build up their dive fitness over the early season.

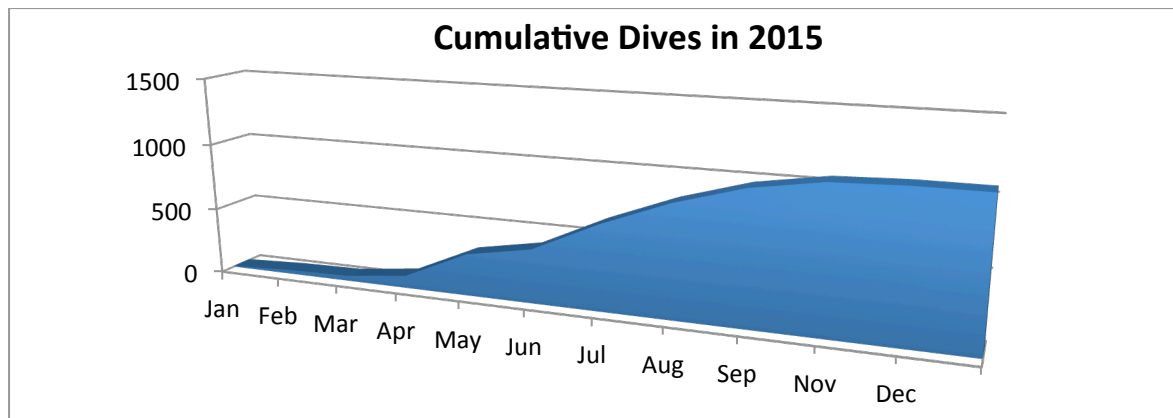


Progressive building of depth and volume – using build up dives and early season warm up sessions

We also encouraged people to make use of the pool sessions pre-season so that they refreshed skills and tested their kit out before jumping off the boat! – See the extract from the 5th January Newsletter below:

“The pool re-opens this Thursday, we have a group of new Ocean Diver trainees starting, I would also encourage everyone to take the opportunity over the next few months for POOL PRACTICE before the main season starts. Just find a buddy and go diving. If you can’t find a buddy, let me know or drop an email out yourself to the Google Group email and ask for someone to join you (macc_scuba@googlegroups.com). We will have an instructor at the pool each week to advise and keep an eye on things. Things to practice:- Buoyancy (you can always get better), DSMB deployment, Compass work, Mask removal (with gloves & hood on) etc, rescue skills etc etc. Also worth dusting off your kit from winter storage and making sure it works before you lose a dive when you jump in during the main season and something fails.”

The cumulative dives completed also demonstrates our progressive approach to the season



4.1.3 Dives in 2015 – the stats

Having logged all the club dives we are able to maintain a database of the data and produce detailed analysis that enables us to track and monitor the club dives.

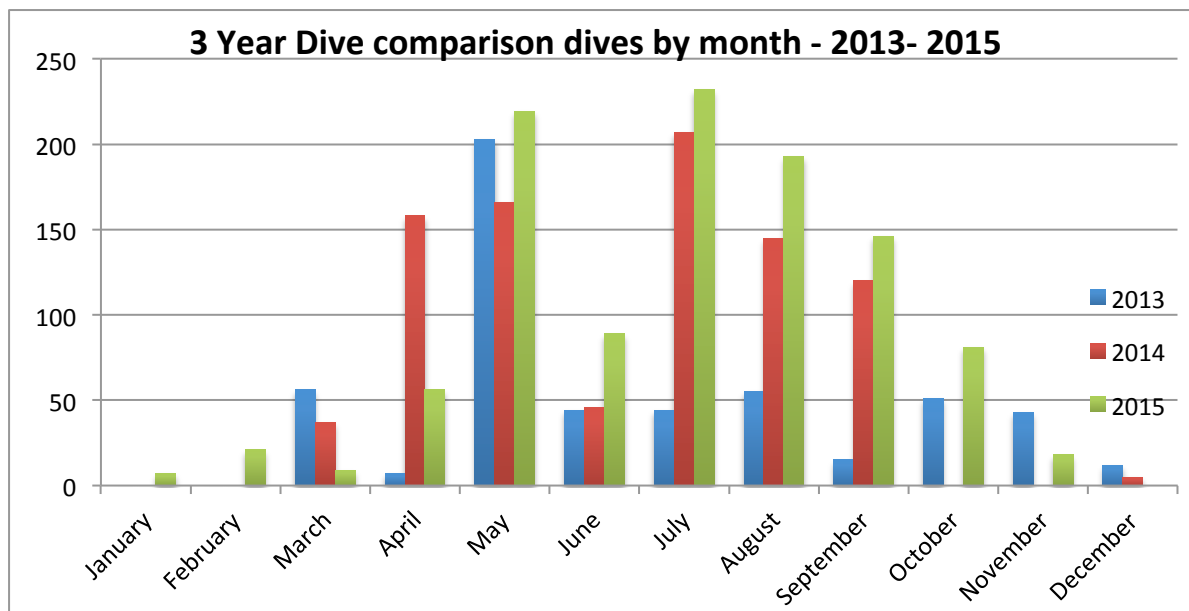
An analysis of the data we hold enables comparisons to be drawn out for the last three years.

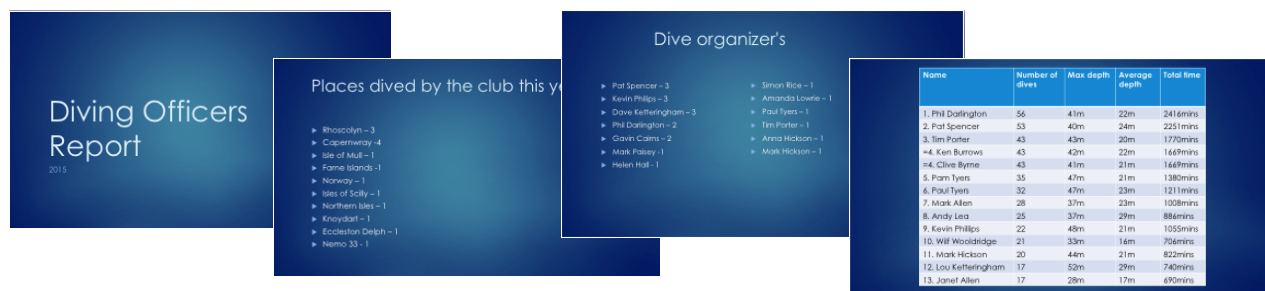

This shows that apart from March and April (which were poor weather and viz months in 2015) we have conducted more club dives each month when compared to previous years. The graph below shows the monthly comparison of total club dives conducted in the last three years.

4.1.4 Dive locations

Our club is located quite some way from the sea; we are 50 miles from the nearest sea as the crow flies and 70 miles drive from the nearest reasonable sea dive. Our club location is denoted by our Cheshire cat logo on the map opposite.



During 2015 we arranged club trips to a number of different UK destinations denoted by the red dots on the map.

The majority of our club diving is done around Anglesey, the closest area with access to a variety of sea dive sites. We decided to locate our boat on the Island for 2015 after canvassing the membership and discussing the options at length with the committee. This decision was made after weighing up a number of factors, including the cost of the storage (£1,100 per year) and the costs of towing the boat for each trip along with the wear and tear and risks involved in a frequent long tow. A number of location options were considered on the Island and in the end we opted for Trearddur Bay.



The club has been lucky enough to run a number of trips away from the UK shores during 2015 with trips to The Azores, Portugal, Malta, Tenerife and Oman. These trips are organized by club members rather than travel agents to keep costs down and we normally work with local dive centers or local clubs in these locations to ensure we get the best diving for our members. As per guidance from BSAC we ensure members pay direct themselves to avoid the club being seen as acting as a travel agent.



4.1.5 Catering for all levels

We recognised that with a proportion of new members joining the club and also our Snorkel Section it was important to ensure we delivered diving that was appropriate to them and also allowed them to develop their confidence and enjoy “real” diving in the UK which meant going outside of the normal inland training venues.

During the year we ran a number of trips specifically aimed at novice divers and ensured that the diving on these trips was progressive and allowed the new divers to develop their skills and move beyond the conditions they experienced during training but in a safe and supervised environment.

In addition to catering for the newer divers we also took a poll of our membership and enquired specifically what kinds of diving people wanted to do. The results were as in the table on this page: 40 people replied to questions (including 5 newly qualified divers) and these are the proportions in each category

The newly qualified divers all said they wanted to continue with their training, it was clear we did not have a wish to do deeper diving (although we already had a group that did tech diving, evidently not many people wanted to join them).

There was a clear mandate for diving new sites and doing more scenic diving as well as to find some better visibility. This led us to try new dive sites and also run some trips further afield (notably Cornwall and the South Coast) to ensure we delivered diving that appealed to the entire membership.

4.1.6 Arrangements for risk assessment, safety and emergency procedures

For all new dive sites we conduct a risk assessment. This is often done as part of an Advanced Diver weekend where the Dive Manager is completing a trip to an unknown site. One such trip was the trip to the Llyn Peninsular run by Steve Welton see page 64.

Alternatively we also seek out new training venues and as part of that work we conduct a risk assessment. An example of this would be the use of Salford Quays as a training venue and its subsequent selection as a location for the club to install a training platform. A detailed risk assessment was carried out for that site and is included in this document in section 7.9 on page 138. We also have an example risk assessment on page 145.

We utilise the standard BSAC casualty assessment forms as well as the emergency procedures sheets that we keep laminated and stored in the club boats and with the dive manager during club dives. In order to keep members rescue skills up to date we also run a Practical Rescue Management course (or refresher for some) on an annual basis, usually early in the season. In 2015 we ran this at Salford Quays.



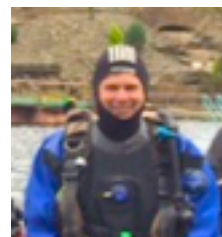
4.1.7 Selected Club Trips 2015

4.1.7.1 Tenerife – Feb 22nd – 1st March

The club took an opportunity to get away early in the season while the weather in the UK was still cool. This gave some of our members the chance to dive in warm clear water well before the UK was warm enough for “fair weather divers” to venture out.



A few lucky ECSAC divers had a week in Tenerife in February 2015. The dive center we used was Aqua Marina situated at Los Christianos. As the beach here was very nice and the surrounding area clean and had a lot going on, with plenty of restaurants, shops pharmacies etc we spent most days in this location.

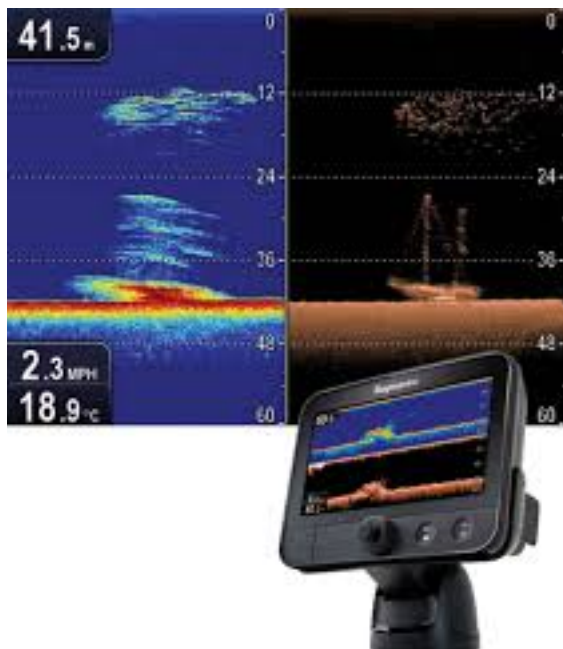


Our accommodation a few miles away was ok but the local resort not as good as Los Christianos. We only managed 3 dives (we got blown out one day, diving was cancelled, as all dives were from a huge rib). Viz was, I guess, between 10 and twenty meters. We saw numerous large rays on the sea bed that took flight underneath us as we approached - massive shoals of fish forming bait balls, so many that at times it went dark. For me the best dive was on a wreck; the small cargo vessel, I guess at about 80 feet in length, hit the reef and wedged **itself** in a horseshoe reef at a depth of 24metres, the bow broken off and lying inside the wreck amidships. As we left the surface we could see the entire wreck and surrounding reef, viz was very good. The stern section and bridge were intact and home to many large what i call trumpet fish, that ignored us and seemed to be used to visitors to their ship. I enjoyed Tenerife diving and will be returning, as always with diving if you get involved and really look you can find interesting critters and make it worthwhile. Tenerife does offer many watersports, and whale & dolphin watching. There is also plenty of sightseeing to be had - Mount Teide and the tree covered mountain range is a must and if escaping the British weather, Tenerife is just the ticket. Oh, it is doable in wet suits.



4.1.7.2 Wreck Locating Day - March

One of our objectives for 2015 was to practice our wreck locating skills and to enable new members to develop their skills in terms of wreck location and shotting. We arranged a day out on the club boat that was not to include diving and just focus on boat handling, wreck location and shotting.



We went out of Trearddur Bay using TopCat and a new Dragonfly Sonar GPS with a downscan facility that would enable us to image potential wreck sites in high definition. We planned to survey a variety of sites (wrecks, reefs and other interesting features identified from charts) and expected to cover over 40nm during the course of the day.

Our specific objectives were to better understand the use of the down scan facility and also to verify our existing GPS marks as well as conduct a search for other potential dive sites based on un-corroborated GPS marks we had obtained from a number of different sources.

The day was very successful, having validated all of the current GPS marks we had stored in the boat's GPS system as well as being able to identify two or three new sites that we were able to dive later in the season. We were also very impressed with the image quality of the Dragonfly unit once we had worked out its optimal settings.



Segontium Wreck on the Downscan

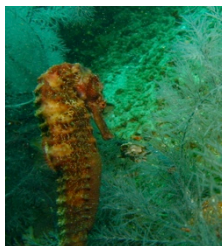
4.1.7.3 Oman - 24th April - 9th May Pat Spencer

We left a cool Manchester on a Qatar flight via Doha to Muscat at 9am and were in our rather swish 4* hotel before 11pm their time. (We even had time for a cup of tea in Doha's brand new airport.)

The first thing that hit us was the 37 °C wall of warmth as our taxi driver took our luggage and loaded it into an air-conditioned 4x4. The next was our arrival at The Millennium Hotel—friendly staff, spotlessly clean sea view rooms with super-sized comfortable beds and a 5* buffet styled restaurant. We spent some of Saturday sorting out our kit at Sea Oman ready for our first



day of diving on the Daymaniyats, a group of islands about an hour's boat ride away. The rest of the day involved eating, walking on the beach and relaxing by the pool.



The diving did not disappoint: 27° C water; 10/15m viz and very little current. We saw every type of reef fish, so many morays (honeycomb, yellow mouthed, grey, peppered and zebra, both in crevices and free swimming: shoals of snappers, juvenile barracuda, red toothed trigger fish, torpedo rays, turtles, puffer, porcupine and lion fish, spiny lobster and the best find, seahorses and a leopard shark). We only saw one other dive boat all the time we were there. The staff and dive guides were excellent; friendly, well organised and knowledgeable.

A change of venue to dive the Musandam involved a 6 hour drive in 2 4×4's plus 2 border crossings (into UAE, out of UEA and back into Oman) — an interesting experience!!! We met up with Mark's friends from Dubai BSAC on board the Dhow that had been chartered for the weekend. This group included Tash, an ex ECSAC trainee, who is now a fully qualified rebreather diver. We then stayed and dived with Nomads for another 2 days.

The scenery was spectacular— jagged mountains plunged into the sea. The underwater topography was its equal. The diving was very different, more challenging and deeper, remote, with drifts of varying speeds. Dive sites with names such as Ras Musandam, White Rock, Lima Rock, Wonderwall, Octopus, Ras Morava and Mother of Mouse. The dive briefings included advice such as “if you get caught in a down current do not inflate your BCD, go with it and fin at right angles to it.”

The night dive from the Dhow on Octopus and the early morning 5.30am dive on White Rock were superb. Shoals of batfish, fusiliers, snappers, red toothed trigger fish, massive groupers, pairs of cuttlefish, shimmering silver and electric blue, soft coral in various shades of purple, yellow, orange, blue and pink, bubble coral with anemone fish darting in and out, hard coral gardens, the sound of reef fish munching, broom tailed wrasse, bannerfish, angel fish, morays — a true fish soup. The high lights for me in the Musandam, the curious bat fish, a porcupine fish being cleaned, seeing my first jaw fish and the group of eagle rays that passed by.



We returned to The Millennium to continue diving on The Daymaniyats. Once again 3 days of calm, well organised and relaxed diving with so much to see. We even stopped pointing out the morays to our buddies as they were everywhere.

We left Mark at The Millenium, as he had booked another two days of diving before his return to work in the Omani desert. Would you believe it –5 whale sharks in two days!!!!

We arrived back on time courtesy of Qatar Airlines to a chilly but very green Manchester.

Was a 15 day trip mega expensive? No.

Would we go again? Yes –September 2016 on The Daymaniyats looks likely.

A big thank you to Mark Parsey who organised this trip for us.



4.1.7.4 Cornwall Tech dives - U-Boats - 23-24 May

As part of our efforts to offer more adventurous diving to the members we arranged a trip to Cornwall to dive some deep wrecks and conduct Advanced Mixed Gas training to extend the range of some of our members down to 80m.



We used a charter RIB based in Rock as it would have been prohibitively expensive to take the club boat down with a small number of divers.

The diving included the U325 at 65 meters it was an interesting and challenging dive.



As an extra bonus we were visited by dolphins on our decompression stops and enjoyed 20 minutes of close encounters with them. Awesome.

4.1.7.5 Summer Isles – 23-30 May

The drive north is always spectacular. The green fields of Lancashire give way to the mountain tops of the Lake District which in turn give way to the southern lowlands of Scotland and the Cairngorm National Park. The views from Inverness to Ullapool are equally stunning. A single track road with passing places takes us past Stac Pollaidh and on to our final destination, Port Beag Chalets, Altandhu.

The chalets overlook a beautiful bay and The Summer Isles. They are well equipped, clean, spacious and above all warm. The downside was it was extremely windy and rather chilly.

We met our skipper Andy in the pub and agreed to meet at The Old Dornie Pier at 9.30am.

This was the pattern for the rest of the week.



We loaded our kit onto the boat and prepared for our first dive. The viz was a decent 10-15m.

The shock was the water temperature, 8° C. It just hadn't warmed up. We dived every day despite the North westerly wind, squally showers and swell. This was purely down to our skipper, Andy's skilful handling of his boat, The Lady Nicola. He did say that we were a hardy bunch and just to prove the point, Phil and Tim completed a scallop dive for him.

The diving was mainly a mixture of reefs, walls and boulder fields although for good measure we dived the wrecks of the Fairweather and the Boston Stirling. The Fairweather was a riot of colourful plumose anemones. The marine life was varied—featherstars, hydroids, bryzoa, starfish, anemones, Devonshire Cup Coral, Ling, wrasse, edible crabs, and for good measure sea hares, nudibranchs, octopus and angler fish. Long clawed squat lobsters were under every boulder and in all the crevices.

We had a great week. With better weather we would have been able to dive the northern and western sides of the islands—a good excuse for a return visit.



4.1.7.6 Llyn Peninsular - June – Steve Welton

Date Friday 26th June 2015 to Sunday 28th June 2015.

Dive Manager: Steve Welton

Dive Team: Kevin Phillips, Mark Paisey, Wilf Wooldridge, Sue Wainwright, Jon Green

Steve organised this trip as part of his advanced diver training. In particular dive planning and management to unknown sites. Steve's write-up of the trip is below.

Friday 26th June 2015.

So Kevin, our DO, and I collected the boat from the club house and set off on the 3 hour journey to the Llyn Peninsula.

The drive was fairly uneventful for a Friday evening and we arrived in good time at our accommodation, stowed the boat and chose the best beds in the static caravan. (trip organiser's prerogative?)

We were staying at the Llwyn Ffynnon camp site at Yffor just outside Pwllheli where we were launching from Saturday morning. The plan was for other members to join us Friday night who were staying in the caravan and the other boat was to be towed from Anglesey where we had the 2nd boat stored. The site had its own bar and we felt it was only fair to sample the hospitality first hand. I must say it lived up to expectations. During the evening I took a call from our other members on Anglesey who had picked up the boat and found one of the wheel bearings was faulty and therefore were not able to tow the boat any great distance. With only 1 x boat available, this was going to have an impact on the number of people able to dive. Not off to the best start with the bearing failure and even with the extensive efforts of some of our workshop team we could not change the bearing by torch light and limited tools. Quickly altered the plans to suit all parties and turned in for the night.

Saturday 27th June 2015

Up early to get a weather update from the coastguard which presented more challenges as the force 3 to 4 increasing later force 5 to 7 did not bode well. Briefings completed and coastguard informed of plans etc. we launched at Pwllheli and headed out to our first site. the wreck of the Timbo which needed to be

dived at low water slack. We located the wreck in good time and deployed a shot line. Divers dropped in and we rotated during the slack window leaving a cox and assistant on board during the dives. Sue, one of the sports diver trainees, had that look in her eye of I am not sure about this as it was a bit lumpy. Kevin took Sue into



the water and it turned out to be her best and longest UK dive to date. Her face was a picture of joy once she finally de kitted. Great to see someone really enjoying the dive that you had been planning for many weeks. Handed over the dive management to Mark Paisey our training officer and I jumped in with my long-time friend and dive buddy Jon Green. Down the shot line, bang on the boiler, fantastic shotting by the on board team! We were buzzed by a couple of juvenile seals which was fantastic to see. Plenty of Pollack and wrasse around the wreck. We had a good bimble around the plate work and ribs of



the wreck on the last of the slack water and located plenty of lobsters, edible crabs and a carpet of star fish. Great dive.

All back on board, quick debrief before heading back to port for a spot of lunch and change of cylinders.

The weather had started to pick up a little but headed out to the 2nd wreck which was the aptly named the challenger. Having located the wreck with the coordinates the sea state was picking up and a few green faces developing nicely. I called the dive off and quickly planned for another more sheltered location. We headed over St Tudwall's islands and found a nice spot in the lee of the wind. Having checked the depth sounder it looked like some interesting topography.



Dropped in a shot line for a reference and current check. All good to go. Quick briefing and we jumped in again with the same pairings. I had couple of skills to complete in the water, mask removal and replacement at 20m, 20m CBL and rescue at the surface which went well and met the criteria for a pass. Other members of the dive team reported good viz with plenty of fish life, anemones and crustaceans. All back on board we headed for port to recover the boat and a full debrief.

We all had a nice pleasant evening meal out together and we retired back to the static caravan. Quick check on the weather forecast for Sunday which did not look too good so likely to have to plan for alternative sites which I had done in advance as a contingency.

Sunday 28th June 2015

The pre-planned dive sites were all blown out on the south side of the Lleyn so we relocated to the north coast. Checked out all the bail out sites but the wind had got the better of us this time around so we headed off back to the club house to stow the boats.

Fortunately I had done enough to get the tick in the box, which completed my advanced diver grade training.

This was the second attempt at diving the challenger which beat me again so third time lucky June 2016 here we come, are you ready!!

4.1.7.8 Scilly Isles – August – Mark and Anna Hickson



This was our 8th trip the the Scillies, staying on St Martins and diving with Tim Allsop. Our group this time consisted of 10 divers and one non-diver, which is a lovely number, both on the boat and off. We began the trip as usual with an overnight stay in Penzance, then took the Scillonian to St. Mary's, the largest of the Scilly

Isles. From there we took the smaller inter-island ferry to St. Martins to begin our holiday proper. It's a long journey - we often comment that we could get to Australia more quickly - but it's beautiful and well worth the journey, which is all part of the holiday. We began

our diving with a true Scillies favourite of mine, Treneme Ledges. This is a typical Scilly dive, walls and walls of stunning jewel anenomes of every colour. The vis, as everywhere this year, was not it's best, only 6-8m! During the week we were slightly restricted by the weather and tides, but we still managed many Scilly favourites, including The Hathor, King Cadwallon, Brinkburn, Juno cannon and anchors, Hanjague and Sponge Hill. One of the joys of the

Scillies is the variety of diving from stunning walls covered in all kinds of anenomes to 18th Century wrecks, where all that's left are cannon and anchors. Luckily for us Tim, our skipper, jumps in and lays a trail for us underwater, so that we don't miss anything, If we're lucky there can be a seal or two about as well.

Above water we sampled the delights of Adams Fish and Chips, freshly caught lobster tails - yummy! Once again our week was over too quickly, we had a fantastic week, both due to the diving and also to the great group of divers.



4.1.7.9 Azores 17-26 July 2015

"Where's that?" was the usual question when we said that ECSAC was diving in the Azores. (Broadly speaking these beautiful islands are mid Atlantic approximately 900 miles west of Lisbon).

We survived the rigors of flying with TAP although some of us required stopovers in Lisbon in order to do so. Lisbon itself is a beautiful and extremely safe city which merits a visit in its own right. 19 of us arrived on Pico (the island takes its name from the volcano which at 2000m + dominates the sky line). We were taken to our hotel which was situated 9km outside the main town of Madalena. The hotel was spotless, the breakfasts marvelous and the views over the vineyards and the sea were stunning.



We had 5 days diving with Gary and Lindsey who own and run Twin Peaks Dive Centre in Sao Roc. The diving was predominantly shore based, from a variety of sites around the island. Morays groupers, octopus, nudibranchs and wrasse were easy to spot in and around the crevices and boulders. Depth hounds descended to 47m to see the black coral on the last day.

One group took a RIB over to the Island of Sao Jorge for a day to dive the caves and the harder amongst us endured the two and a half hour RIB trip from Madalena out to Princess Alice Bank, an underwater sea mount, to dive with the mobula rays. The end of course justified the means, as seeing these graceful creatures in the clear blue waters of the Atlantic was pretty amazing. Our 2 non divers had an equally fruitful trip out to Faial to go whale watching. Not only did they see sperm whales but pods of dolphin entertained them on the way.



Azorean history is bound up with the sperm whale. Did you know they ground whale bone into flour? Pico itself is largely

unspoilt. Black volcanic rock is used in constructing houses and the hundreds of dry stone walls that protect the vines. The square in Madalena was the meeting place for families and tourists alike. We were entertained by local choirs, brass bands and traditional dance groups. Restaurants were small and family run so eating out was very enjoyable.

4.1.7.11 Anglesey RIB dives - 22nd-23rd August

Derbent Deep Wreck – Phil Darlington

This was a trip put together to appeal to the more adventurous in the club and took us further offshore than normal and somewhat deeper than the more usual Anglesey diving done with the club.

An early morning slack meant a group of bleary eyed divers met at Bull Bay to load and launch Top Cat. The sea was mirror calm as we made our way 7 miles offshore. The



wreck was located, shotted and the 3 pairs of divers descended in still water as our 'educated guess' at slack had proven to be right. The shot was on the Bow and the divers explored the forward holds with 3m to 4m of viz before making a safe return to the surface. We returned on Sunday flushed with success and another calm sea only to either miss with the shot or have it drag off the wreck; the Sunday dive was a 42m seabed in the vicinity of the Derbent.

This dive also sparked a very good discussion in the club in relation to gas planning and enabled us to engage a number of members in a healthy debate about appropriate equipment for more adventurous dives including the use of bailout cylinders and deco gases. This provided the opportunity to discuss deeper diving and the need for careful planning and engaged some members not on this trip so well they decided to undertake the Accelerated Decompression SDC which we ran along with a Buoyancy and Trim Workshop later in the year.



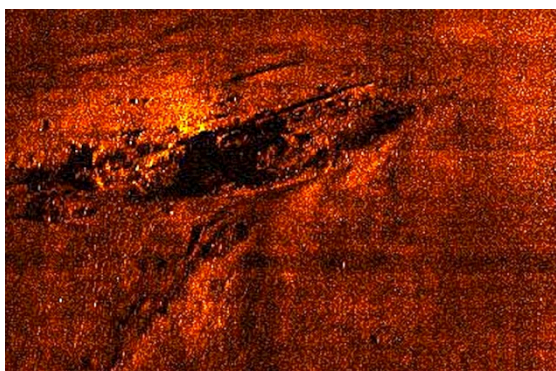
4.1.7.12 Shipwreck Project 7-11 September

East Cheshire Sub Aqua Club brought together members of Darwen, Stafford and Gwynedd Sub Aqua Club to sample a week with the Shipwreck Project in Weymouth on 7-11 September. The Shipwreck Project is a story hunter at heart and anyone diving with the Project does so with the aim of adding to that story. They search out new undived wrecks and sites of historic importance and document, photograph and log them and so add to the increase of our rich maritime history. Our group was primarily interested in offshore trimix sites but also tried their hand at target diving Chesil Beach in 16m.

All of the diving is done from Wey Chieftain 4 a fast catamaran. The boat is spacious and very well equipped with diver lift and spacious toilet! The first site planned was the sailing clipper Aracan, similar to the Cutty Sark, in 55m. This site has not been definitively identified but the cargo contents, especially belt buckles from the Staffordshire Regiment, indicates the Aracan. Huge metal hoops and an abundance of pottery and glass artefacts mark the wrecksite cargo.

The boat normally arrives on site 45 minutes early and hooks in via a rebar grapnel. For our dives we also deployed a deco trapeze with spare gas, divers are required to return via the shotline. Any items identified on the seabed and there are many, are photographed and catalogued to become data for the Project and to aid further research.

Our second dive was 29nm out towards Cherbourg on an early steamer as yet unnamed in 63m. She has a square engine block and flywheel similar to the arrangement seen on the Warrior in Portsmouth. This suggests a mid 19th century wreck. The Project was interested in recovering one of the blocks known to lie around the engine. If the blocks were patent fuel then this suggests a 60-70 year old vessel when sunk as patent fuel blocks date from around 1900. The blocks are normally also stamped so a manufacturer could be determined. As always the shot was exactly on site from skipper Grahame Knott despite only being 2m above the seabed. A fuel block was quickly identified at 63m and photographed, a dive around the engine and flywheel followed.



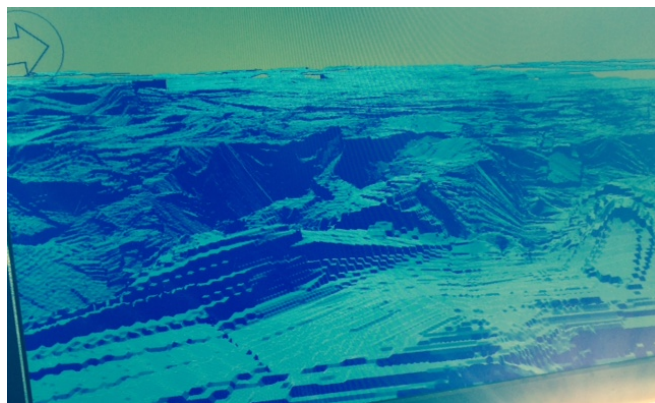
The third day saw a change of scene and the opportunity to target dive a developing wrecksite off Chesil beach. The Project spends much time sidescanning areas for targets on Coastal Guardian their survey ship.

Clusters of targets indicate potential wrecks. To gather this data the sidescan towfish needs to be pulled approximately 5m above the seabed scanning 50m either side. Towfish are expensive and it's vital to know that the fish will not collide with the seabed. The Project has therefore collected lots of soundings in the areas of interest enabling a picture to be made of the seabed in the areas of interest where charts are inadequate or not surveyed.



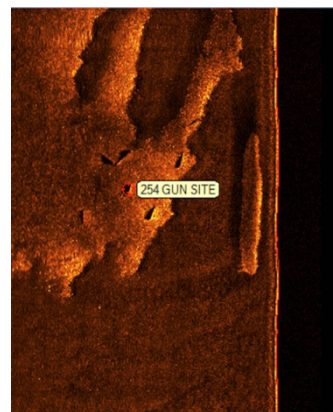
Coastal Guardian survey vessel

The Project uses Olex which allows users to collect data from a ship's echo sounder and GPS direct to a digital database. This can be immediately visualised on screen which can be shared between users.

The sidescan uses an algorithm to produce an 8 figure coordinate at the click of a mouse on any point of interest allowing it to be shotted and dived. (See the screenshot of the cannon site on the right). The Project aims to place the shot within 5m of the site and divers have to

follow the shot down without pulling on it. A circular search follows by attaching a line to the shot via a prussik knot 2-3 m above the seabed. Normally the target is very close such is the accuracy, if not its back on the boat and on to the next target. This is great diving for any BSAC club as its "diving for a purpose" and has something for every interest. We felt that if you enjoy diving why would you not get involved. If you are interested then contact Richard Bright-Paul at the shipwreck project.

A family focused weekend to enable partners and kids to join the trip with diving early in the day and activities in the afternoon including water skiing and then a meal arranged for the whole group in the evening.

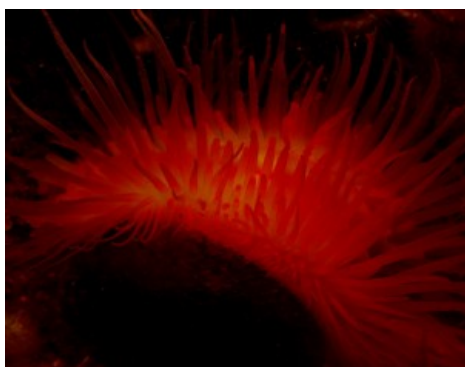


4.1.7.14 Sound of Mull 19-26th Sept 2015

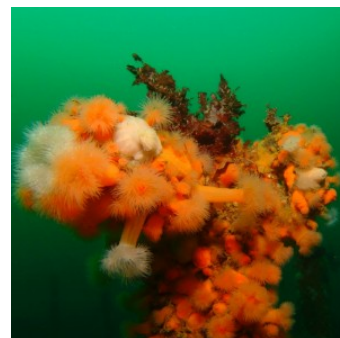

4.2 Expeditions:

4.2.1 The Shipwreck Project

ECSAC teamed up with the Shipwreck Project for a dive expedition aimed at diving previously undived wrecks and dive sites selected from potential dive sites identified from Sidescan Sonar data shared with the club by the project. See the trip report for this at 4.1.7.12 on page 71.



The Shipwreck Project is a Community Interest Company (CIC). That means that it is a not-for-profit organisation with an isolated fund to be used for the benefit of its members. It is obliged to provide annual accounts to Companies House, and in the case of being wound up any remaining funds would go to charity. Funding is generated initially through membership subscriptions, which a number of members of ECSAC have taken up, and it is hoped that these funds can be supplemented in future by seeking public funding for specific projects.

The Shipwreck Project aims to invest the majority of their funds in research. Some of those monies will go on archive subscriptions and searches. Some will go on commissioning seabed surveys. These surveys will be primarily conducted using the survey vessel Coastal Guardian. Coastal Guardian is not an asset of The Shipwreck Project, it is under separate private ownership. A proportion of the ship's time will be dedicated to conducting survey searches for The Shipwreck Project. The Shipwreck Project will not pay commercial rates for the vessel (use of the vessel and time effectively will be provided free of charge); it will simply cover the cost of fuel used on the surveys. In return, The Shipwreck Project will have sole access to the findings of those surveys. Kitted out with OLEX, high frequency sidescan sonar, dive deck and a 60m drop camera, Coastal Guardian is pretty unique in the UK in being a privately owned, survey vessel with true wreck-exploration capabilities.

The diving organised through The Shipwreck Project is, in the UK, conducted on Wey Chieftain IV – a bespoke dive catamaran with diver lift. Wey Chieftain IV is dedicated the majority of its time to it. Members of The Shipwreck Project who dive on Wey Chieftain IV will pay for dives on an individual place basis, so subscription funds will not be used for this purpose. Likewise, on foreign diving or non-diving trips, members will pay as they go.

The Shipwreck Project intends to bring together a broad range of people with skill and expertise in relevant areas of research, people who want to get involved in discovery at the sharp end, and people who simply want to learn and have fun. Some of their members are divers, with their natural interest in the sea, and others interested from a more historical basis. East Cheshire's particular skillset brought to bear on our trips was deep technical diving and also IT skills which enabled us to assist with Sidescan Sonar data reviews. We also provided the project on some ideas for how to promote the project and run more widely accessible trips, some of these ideas (creating special trips with a mix of project tour and guided target diving for dive clubs) have been implemented for their 2016 season.

ECSAC also got an honorable mention in the National DO's speech at the 2015 BSAC Conference where Sophie mentioned our work with the Shipwreck project.



4.3 Scientific:

4.3.1 Project Baseline



What is Project Baseline? Project Baseline is a grassroots, environmental conservation initiative. The organization exists to support people who are invested in water quality and availability by providing a platform that gives voice to otherwise under or undocumented aquatic areas. It is a global initiative that allows people from all over the world to see what's happening in various parts of the globe through one central database - See more at: <http://projectbaseline.org/>

Why Project Baseline? Gradual loss of knowledge about what should compose a healthy ecosystem leads each new generation to accept a different environmental standard; thus, our "baseline" shifts to accommodate an often changed, and, perhaps more importantly, sometimes degraded environmental 'norm'.

ECSAC's involvement with Project Baseline



Gemma Thomas – “We've collaborated with the Project Baseline North Wales project. DiveLife and Global Underwater explorers originally set this project up due to North Wales being premier dive spot in the UK. ECSAC regularly dive in the area and house one of their ribs here, so have started to build up data and awareness of popular sites both inland and off shore. Our aim over time is to build up a picture of changes, so future generations can see what may have changed, for better or worse.”

ECSAC objectives for Project Baseline

Build awareness in the club and encourage members to be aware of the sites they are diving and what's happening there in terms of visibility, sea life, conditions.

Narrow down to a couple of sites that have meaning to ECSAC to monitor well over the next 5 years.

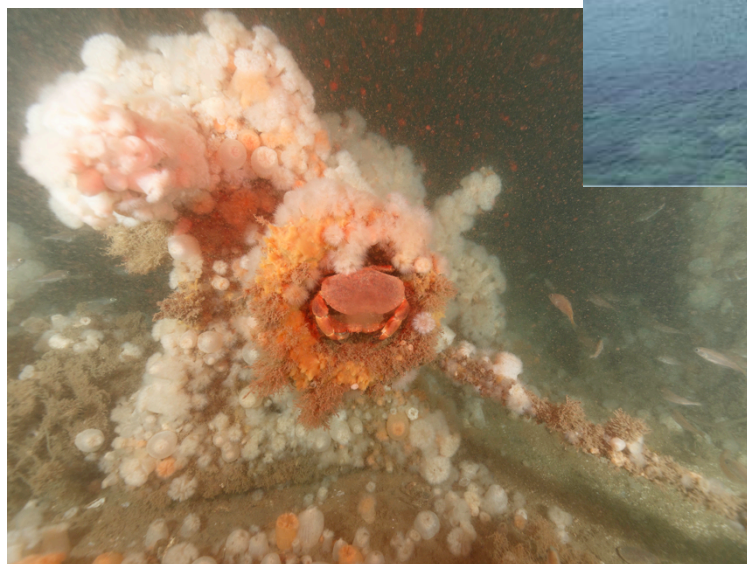
Promote our work to other BSAC clubs and other divers in North Wales via Facebook and discussion, so that other divers can start helping collect information and take ownership for our local dive sites.

What's happened so far -

Gemma Thomas delivered a talk to ECSAC members on Feb 19th attended by 30 members



Dive sites visited and documented in 2015 included – March, Trefor Pier; June, Segontium Wreck off Anglesey; July, Bulls Head sites, however viz was poor.




What's the plan going forward -

We will aim to collect more evidence and document the sites we have already visited using the baseline datum points we have already photographed and we will also extend our list of monitored sites as time progresses. This information will all be fed back to Project Baseline.


We will set our target sites for 2016 so that we are committed to documenting and maintaining a record for up to five sites. We will then monitor these each year. Once we have our sites agreed and a dataset established it will be about our taking ownership of these datasets and building up a strong picture of how they develop and enabling a rich picture to be available for future generations, so we can preserve them for future divers.



Gemma Thomas has collated the work so far and uploaded this onto the Project Website at www.projectbaseline.org in the section for North Wales.



In moving this project further forward we aim to gain commitment from our club divers to gather pictures and get more people confident with how to take part and develop a strong working team in the club to make sure we plan in diving at the chosen sites for next year. We also include Project Baseline in our outreach activity and aim to encourage and involve other clubs.



4.3.2 Seasearch

ECSAC have been involved with SeaSearch for a number of years. Seasearch is a project for volunteer sports divers who have an interest in what they're seeing under water, want to learn more and want to help protect the marine environment around the coasts of Britain and Ireland.

The main aim is to map out the various types of sea-bed found in the near-shore zone around the whole of the Britain and Ireland. In addition we are recording what lives in each area, establishing the richest sites for marine life, the sites where there are problems and the sites that need protection.



Sea Search has been championed within our branch by Pat Spencer. Pat has been diving with ECSAC for over 10 years.

Pat says "I became involved after attending a 2 day course run by Sea Search North Wales coordinator Liz Morris. I completed my observer qualification with Sea Search North Wales and my surveyor in the Shetland Islands with Jo Porter and Paul Holmes. Since then I have taken part in Sea Search data collecting in North Wales and in Scotland. I have also spend a weekend in Loch Sunart and a week in Orkneys in 2015. As part of these trips I have been able to observe and log many interesting and important marine species. Notable ones include:

Yellow Ringed sea Squirt.

4.4 Competitions

We have a set of awards within the club that have been awarded for many years. These include Diver of the Year and Trainee of the Year (selected and awarded by the Diving Officer) and Club Member of the Year, which is voted for by the membership.

Diver Of The Year

This is awarded by the Diving Officer and is normally awarded to the diver who completes the most club dives in the year, reflecting their appetite for diving and also their support of club events.

In 2015 this was won by Phil Darlington



Not only did Phil do more training than anyone else in the club, 25% more than the next most dived diver and 325% more than the average diver in the club, he also worked tirelessly behind the scenes keeping the boats going and servicing the club mini bus on the road. He also organised a lot of club trips as well and so the award went beyond just the diving.

Ocean Diver of the Year (Originally named Novice of the year).

Again decided by the Diving Officer but with input from the Training Officer and training team. This usually reflects a diver who has progressed through training showing particular skill and commitment and also then moving on to dive with the club and make a positive contribution to the club in either a diving or social capacity. The DO will present these awards at the annual Dinner Dance and he/she will make a supportive speech recognising the individuals selected along with the reasons they have won the award.



For 2015 this was won by Alison Brammer, a new member in 2015 and someone who progressed through her Ocean Diver training and used her qualification whilst on holiday in Hawaii as well as opting to continue with her training through to Sports Diver in 2016.

Alison has also been active in helping with social events and joining in on a number of the club's working parties and really thrown herself into the club's activities.



Club Member Of The Year. (now known as the Neville Oldham Memorial Trophy).

This is decided by the Members in a 'secret' ballot arranged in advance. The winner is only known by the person arranging the engraving, with the trophy being awarded at the annual Dinner Dance and Awards Ceremony.



This award has been given annually for the last 42 years.

In 2015 this was won by Kevin Phillips.

Each winner receives the trophy and a small keepsake of a crystal tumbler engraved with the name of the trophy and the year.

5 General activities

5.1 Branch meetings:

We hold weekly club nights on a Thursday each week, these are from 8pm till late and are held at our clubhouse in Macclesfield. We also have use of the swimming pool on Thursday nights (at Macclesfield Leisure Centre) so instructors and students will usually arrive soon after 9pm to join the club night. For details of the clubhouse and bar see page 51.

We regularly hold other gatherings of members at the clubhouse including a number of social events (most are open to other clubs as well, see page 84). In addition to the numerous social events we also hold monthly working parties at the clubhouse to maintain the club and our equipment at which volunteers get treated to lunch.

We have an annual Christmas Party (usually the last Thursday before the Christmas week).

We now hold regular Instructor meetings to ensure that our training team have the opportunity to feedback on how training is running and how it is being managed as well as discussion around training techniques and progress of students. This is also a good forum for exchanging hints and tips to less experienced instructors and comparing teaching methods and ensuring we approach training in a consistent and fun way.



In addition to our own club's use of the facilities we are happy to host regional and SDC events at our club and though 2015 were able to open our facilities to a large number of non-ECSAC members. This will continue through 2016 and we have now confirmed this with Phil Alberts the Diving Support Officer at BSAC HQ.

The committee also holds a monthly committee meeting at the clubhouse (usually the first Tuesday of the month) at which branch matters, diving, finances and general administration are discussed.

We also hold our annual AGM in March each year where we feed back to our members on progress through the year, provide details of club finances (annual accounts – see page 133 for details of these) and also hold officer elections for any positions that need filling. We also take this opportunity to put important matters in front of the members to ensure we obtain their feedback in an open forum. This meeting is fully minuted (as are the committee meetings) so that a formal record is kept of the club's management.

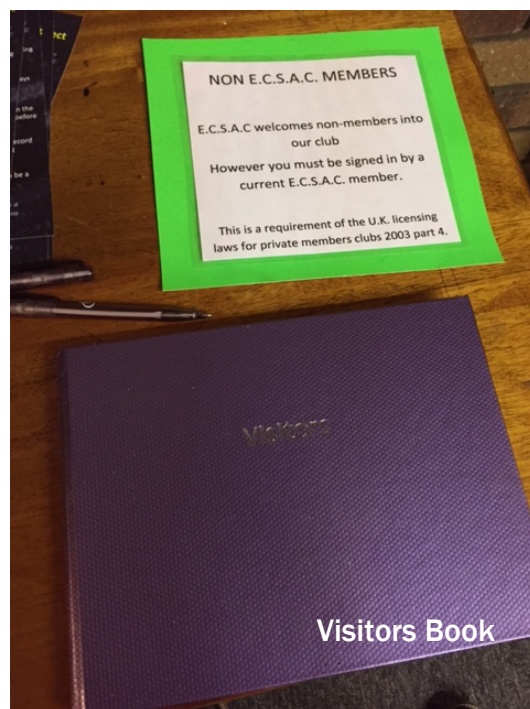
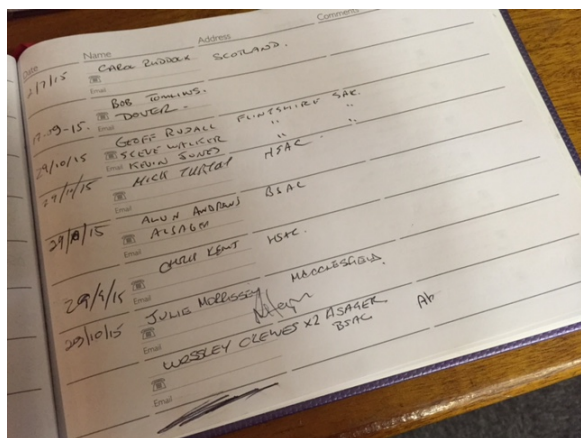


5.2 Social:

5.2.4 New member welcome evening – 6th August

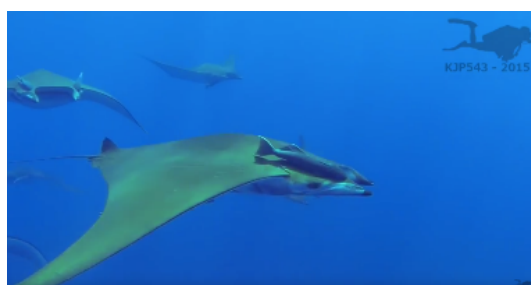

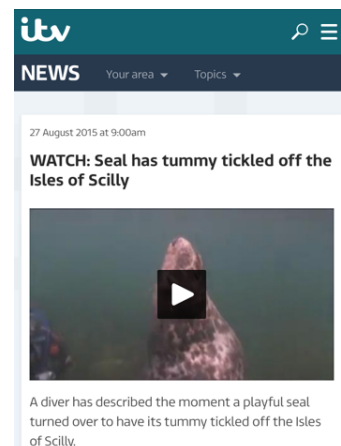


5.3 Publicity:

6 Special achievements

6.1 Training Platform Project



We worked hard in 2015 to ensure that we delivered a scuba training platform in



Salford Quays in Manchester that would have a long-term benefit to the scuba community. We have created a detailed user guide that we issue to anyone who wants to use the platform upon request; so far we have issued 5 copies of this to other dive clubs and organisations.



So it was on a damp and grey November day in Salford that East Cheshire Sub Aqua Club got a hardy team together that included a helper from a neighboring club and set about installing a scuba training platform at a depth of 5 meters that will enable Salford Quays to be used more effectively as an open-water training venue.

The original idea for the platform was first hatched on a similarly grey day back in February 2015 when East Cheshire Sub Aqua Club were running a Practical Rescue Management SDC in the main watersports area in Ontario Basin. This SDC event saw us launching one of the club boats and inviting three other clubs along to run a number of very realistic rescue scenarios both from the shore and in the boat. We also put divers on the bottom to carry out a search and rescue that kicked up a bit of silt.



We returned again in July (on a much nicer day) for a Search and Recovery SDC run by ECSAC and crossover training for some of our new members; this again involved other clubs with one person coming all the way from Yorkshire to attend. It became apparent that although it is a great venue for surface training and an interesting venue for a dive (with Pike, Perch, Tench and Carp in the water and good viz when undisturbed) it was not ideal for static drills on the bottom as there can be quite a bit of silt, which if divers settle on the bottom soon reduces the viz to near zero.



With the successes of our previous training outings and buoyed by a real sense of purpose we therefore decided to build a platform that would allow us to make better use of the site and we set about designing a training platform that would enable us to extend the use of this relatively local facility. We also wanted to provide something that would be useful to other scuba divers and make the basin an easy choice for quick shallow training outings. In addition to the design of the platform we also had to ensure that we obtained the relevant permissions from both the council and from the custodians of the Watersports Centre, Salford Community Leisure. We also approached BSAC HQ to ensure that the insurance requirements we were asked to comply with were covered by our standard BSAC insurance. Happily our standard BSAC third party insurance cover fitted the bill and all parties were happy with what we were proposing once we had crossed all the t's and dotted quite a few i's.

With all this in place we set about sourcing the materials for the platform and using our club members' extensive network of contacts we managed to get a scaffolding tower for the base and track down and purchase some galvanized gratings from Vivian Dive Centre in Llanberis. Having invested a very modest sum of the club's money in securing these along with the necessary hardware to complete the project we then arranged transport to get the gratings back to the club after collecting them on the way back from one of our club weekends on Anglesey.



We then set about the job of building the platform and creating a safe training area in Salford Quays that will provide a two-meter by three-meter solid base away from the silt in the basin. We are lucky enough to have our own custom built boathouse back at our club in Macclesfield and this doubled as the workshop for the platform build. Our skilled team of volunteers pulled together all the various parts and set about the build led by our man of all skills Phil Darlington.

With the build underway we had to focus on where to locate the platform so while the build team were completing the fabrication we put together a dive team to survey the basin and settle on a location and complete a risk assessment of the site.



One evening in October we put divers in the water to survey St Peter Basin. This basin is adjacent to the main Watersports Centre's Ontario Basin and is a quieter backwater in the Salford Quays complex away from the busy surface traffic of the wakeboarding, triathlon and boating that takes place in the main basin.



The dive team (Roger Tomlins and Kevin Phillips) completed the survey and found a level area with the least silt, ideal for locating the platform and a short swim from the entry steps. We



actually found that the silt varied from 20cm in some areas all the way up to 1.6 meters deep in others. We selected an area with the

least silt to ensure that we could safely site the platform on the solid concrete bottom of the basin. The survey was written up along with a site risk assessment and plans submitted to the Watersports Centre and the Council for approval. These plans were accepted, as were details of the BSAC insurance that would cover us (and other BSAC clubs) when using the platform. With all this in place we agreed a suitable date that would allow us to bring together a team to install the platform and have the relevant surface cover in place from the Watersports Centre team. So it was on a surprisingly warm November day that the team met in Salford to complete the install. We had team members from both East Cheshire and Hartford Sub Aqua Clubs on site and gathered on a Saturday morning to brief the team and prep for the install.

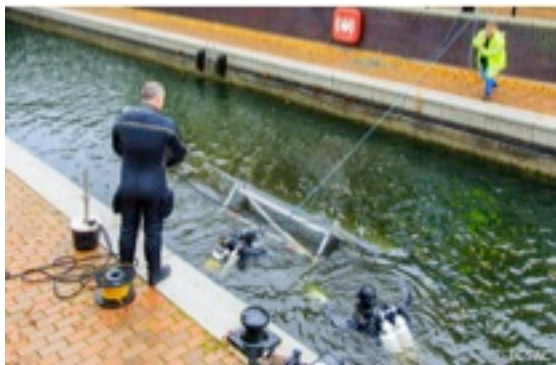

We initially dropped the platform into a connecting canal ready for fitting the heavy ballast legs as these made it very hard to maneuver on dry land.



Once we had completed the construction the platform was set on the bottom of the canal and then we fitted large lift bags to float the platform ready for it to be moved out of the canal and into position above its intended site in the basin. Our in-water team moved the platform into position and then lowered it down onto the bottom of the basin. Once lowered we fine tuned its location and then used the adjustable legs to level the platform.

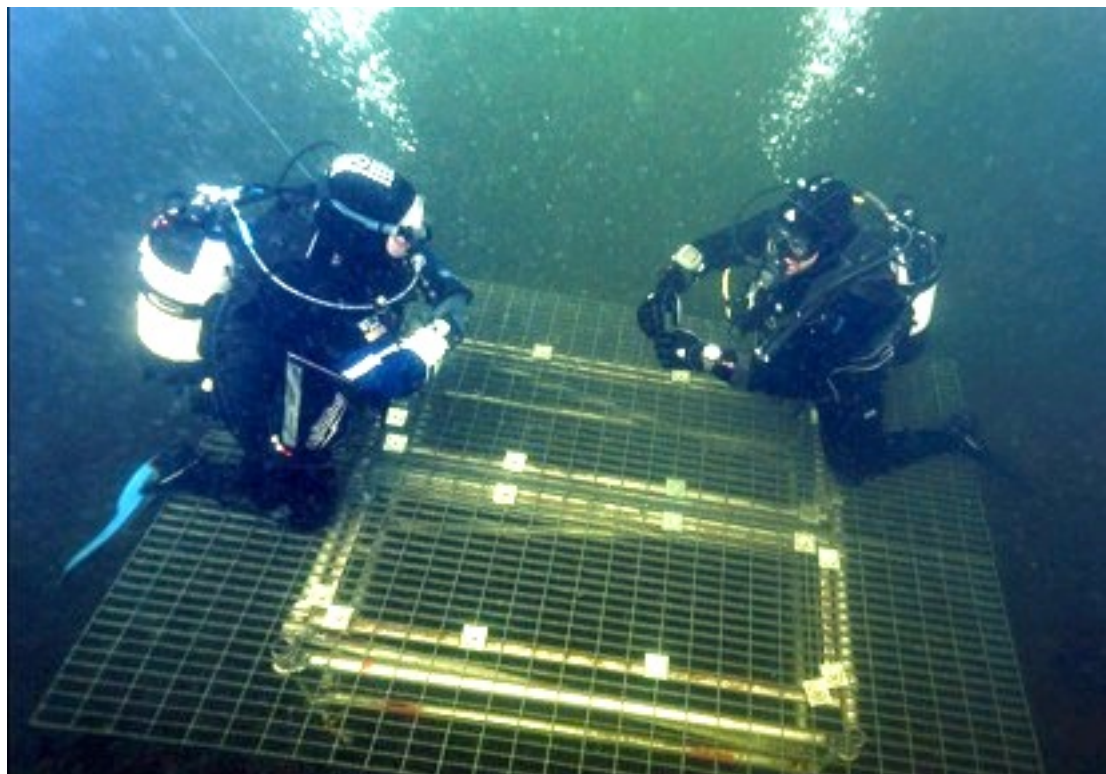


Having sited it we then attached a line running from the entry steps right to the top of the platform which now sits level at 5 meters. This will enable users to follow the line straight from the steps to the platform and avoid kicking up the silt and ensure that they find their way easily.

Within minutes of the installation we noticed a number of Perch had taken a great interest in the platform and took up residence underneath it adding a bit of extra interest for

future users. The team feeling suitably pleased with a job well done retreated to the swanky offices of Smooth Radio within the Quays complex where one of our club members works. We were treated to coffee and cakes and had chance to reflect on the achievement and post a few updates on Facebook and Twitter. Before our coffee had chance to cool down we had already had enquiries via Facebook from two other BSAC clubs who were interested in using the platform! Since then we were delighted to see that the project had indeed been successful and delivered a facility that would be of value to the Scuba community in the North-West. 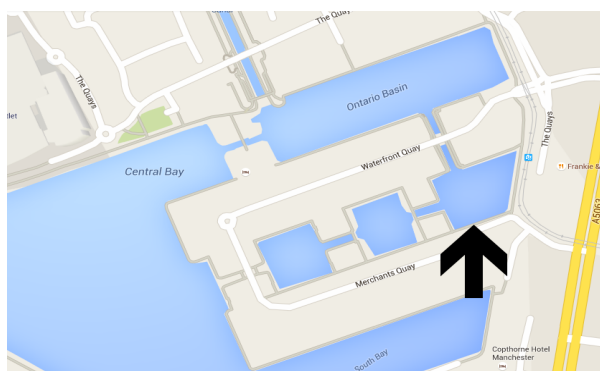

This project was led and initiated by East Cheshire but involved input from Hartford and Congleton Sub Aqua Clubs and developed with cooperation from both Salford Community Leisure (a company registered under the Co-operatives and Community Benefit Societies Act 2014 associated with Salford Council) and the Helly Hansen Watersports Centre at Salford Quays. It was however fully funded by East Cheshire Sub Aqua Club.



This project is intended to enable Scuba Instructors to safely take trainee divers into the basin in Salford Quays and conduct training on a raised platform that will ensure we keep the training away from the silt present in the basin. This will provide a stable and safe location in which to conduct training.

The basin itself is located within the Salford Quays complex; St Peter Basin is next to the Salford Quays Tram Stop, in between Waterfront Quay and Merchants Quay. The postcode is - Salford M50 3WL.

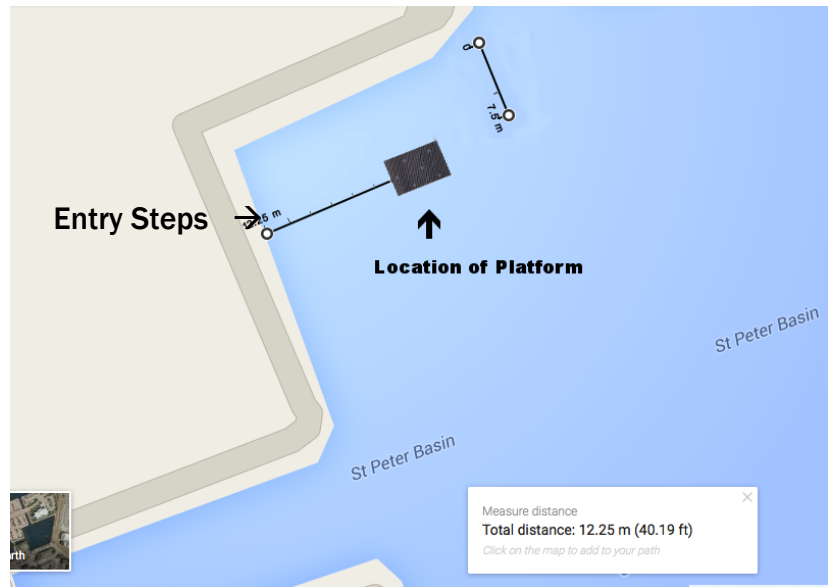
Location of the Platform

Having conducted a survey of the basin it was clear that the silt levels (up to 1.6m) on the south and east sides of the basin were very deep and would potentially cause difficulty not only in siting the platform but also in creating poor viz as divers travelled to and from the platform.

On that basis and also taking account of access and parking, the recommended location for the platform is in the North-West corner, sited away from the entrances to the canals and in an area of low silt (20cm).

The survey plan is included below for information.

It was decided that the platform should be set level and situated 12.25 meters from the entry steps and 7.5 meters from the north wall of the basin.



A guideline was also installed, connected to the base of the entry point steps and leading to the left corner of the platform to enable students and instructors to easily locate the platform after entering the water and avoid kicking up the silt on their way over to it. This was belayed and lifted off the bottom of the basin using some of the blocks that were already present in the basin. This also ensures that it is usable as an easy means to navigate back to the entry/exit steps from the platform even in low viz conditions.



Parking and Access

St Peter Basin can be accessed from either Waterfront Quay or Merchants Quay. Both of these have limited parking which is available at weekends or after 6pm in the week.

The best parking is on Waterfront Quay as there are more spaces here and it avoids a longer walk to the recommended entry point via the steps on the north-eastern corner.

Access to the car park for vehicles is currently blocked by a locked barrier. However it is a short walk once kitted up and access to the steps is quite easy.

Pedestrian access once kitted up is via the path at the side of the building

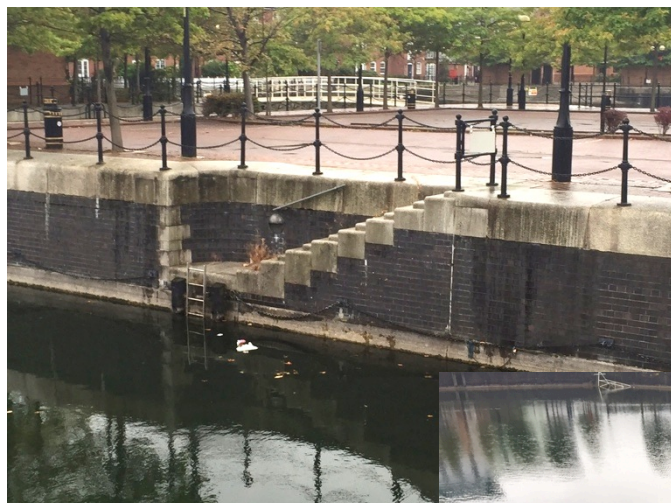
Then across the car park.



Waterside Access

Prior to using the site the WaterSports Center should be notified and all divers registered using the form on page 137. Registration lasts for one year.

Access to the water in the basin can be gained via a number of sets of steps. The recommended entry point is via the steps marked on the previous page, on the Waterfront Quay side of the road.



The gate to the steps is not locked



There is a life preserver located next to the steps

The bottom stone step is actually over 50cm out of the water and at the base of the ladder the water is only 1.5m deep so a giant stride entry would not be advisable. We would recommend an entry via the ladder into the water (without fins) and then fit fins whilst in the water.



Exit would best be achieved after removing fins, weight belt and scuba gear and then climbing the ladder. The addition of a knotted rope (as depicted by the blue line on the photo) connected to the post above would also aid exit from the water as the ladder is quite low.

As part of the approval process ECSAC has undertaken detailed site surveys, risk assessments and obtained clearance from Urbanvision, Salford Council, Salford Leisure and the Helly Hansen Watersports Centre. A copy of the Risk Assessment is included at Appendix 7.9 on page 138.

6.2 Grant application to expand community and youth group support

In 2015 we decided to pursue grant funding for club projects; this was built into our club objectives. We reviewed projects we would like to pursue and as a result we defined a specific project that would allow us to create a resource to expand our delivery of scuba try-dives and training for local community and youth groups, including Scouts, Sea Scouts and Girl Guides. This project is to deliver a new set of SCUBA equipment for pool and open water use and two AEDs (automated external defibrillators) for use in training as well as training for instructors to deliver the BSAC "Diving for All" course thus expanding the range of people we can offer training to. Although we do a number of try-dives at present we are limited in how many we can deliver by the availability of equipment. At any one time we have ten or more members in training and are unable to meet the demand from the community groups.

The application summary is as follows:

We have reached the capacity of our current equipment and are having to turn away requests from local community groups to conduct Scuba and Snorkelling training. We have, over the course of 2015 increased the number of instructors within the club and so have capacity to run courses and take on extra young people but we have a limited stock of training equipment and this limits our ability to expand this service. The funding provided by this grant would enable us to deliver significantly more training and allow us to expand the numbers of participants and to be able to support them through longer term scuba training as well. We also aim to encourage family involvement so that parents and carers can become involved thus ensuring that the young people involved develop skills they can use long after the training has been completed and join in with club trips and activities as they grow up as well as partake in Scuba Diving later in their lives with a recognised international qualification. As a non-profit CASC status organisation, East Cheshire Sub Aqua Club, part of The British Sub Aqua Club (BSAC), is a very long standing part of the community and has been actively training the local community in snorkelling and scuba diving for 53 years. The strength of the club's presence within the community is demonstrated by the support received from local scout groups and others in the region (see attached supporting letter). As a non profit organisation, the club relies on qualified club members to volunteer their time to provide training for new members from the age of 6. We provide snorkelling courses, scuba diving courses and pool hockey to all club members and their families as well as community groups who come along and use our facilities. Our ethos is to encourage people of all ages to keep fit and to learn new sports. A big achievement for the club has been the success of our snorkelling courses for the local Scout groups, Sea Scouts and Girl Guides which involve young children from 5 to 18+ and to date the club's instructors have trained and qualified over 100 scouts with some progressing to diving with the club. In 2012 the club was awarded the BSAC "snorkelling branch of the year" which was an amazing accolade reflecting the hard work and dedication of club members and their passion to involve young children and adults in water sports. We are keen to expand our involvement with the youth groups and want to embark on a project with Scouts, Sea Scouts and Girl Guides but we are limited by the availability of equipment. This project would enable us to drastically increase our delivery to these groups.

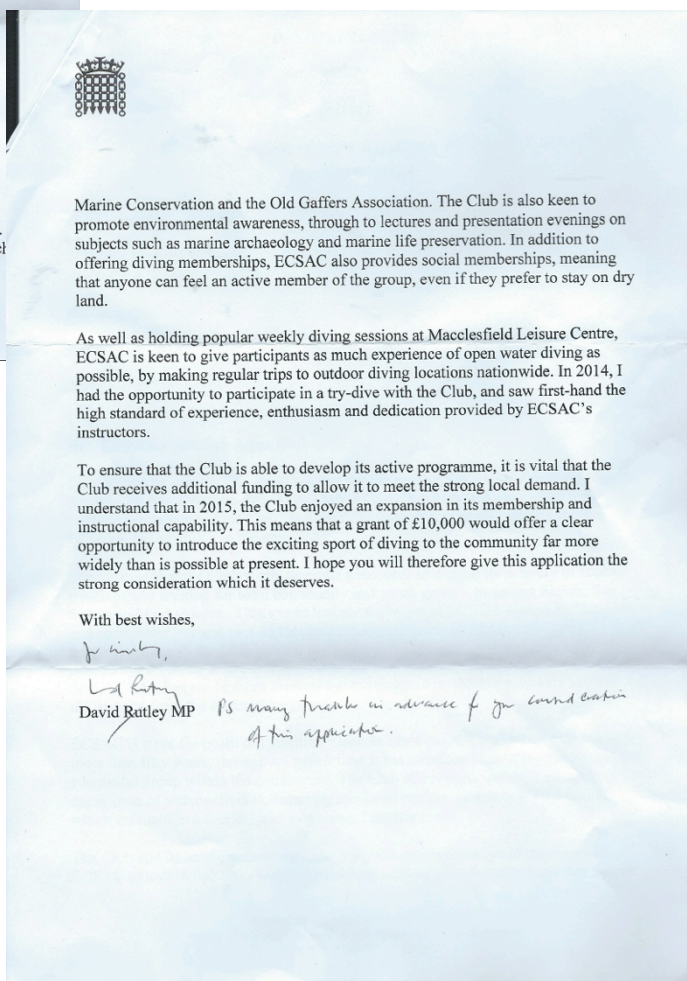


6.2.1 Letter of support for our project by our local MP.

7.1 Club Rules

Revised August 2013

EAST CHESHIRE BRANCH, NO. 100

OF THE BRITISH SUB-AQUA CLUB



Bye_Laws

The rules of the Branch to which each member shall be bound shall be those currently adopted by the British Sub-Aqua Club (hereinafter called "B.S.A.C.") and in addition each member shall be bound by the current version of the bye-laws:

1. Title

The Branch shall be known as the East Cheshire Sub-Aqua Club (hereinafter called "the Branch")

2. Objects

The aims and objects of the Branch shall be to provide for its members the facilities, opportunity and training for diving in accordance with the standards of the B.S.A.C, together with related social activities.

3. Headquarters

The headquarters of the Branch shall be at 2, Lower Bank Street, Macclesfield SK11 7HL, or at such place as may at any time be decided by the General Committee.

4. Clubhouse

The Branch may maintain for the convenience of its members a Clubhouse. Such Clubhouse will operate under the name of East Cheshire Sub-Aqua Club, the control of which is vested in the Branch General Committee (hereinafter called the General Committee).

5. President

The Annual General Meeting may appoint a President for the ensuing year and he/she shall be ex. Officio, a non-voting member of the General Committee.

6. Membership

6.1. Membership is open to all applicants, regardless of ethnicity, disability, nationality, sexual orientation, religion or beliefs, but diving membership is subject to the medical requirements as set by the B.S.A.C. from time to time. There shall be seven classes of member :-

6.1.1. Full Diving, Abated or Adult Snorkelling Member who may be any person deemed suitable by the BSAC. Associate member who may be of any age but shall not be entitled to participate in diving activities.



- 6.1.2. Honorary Member who may be any person invited by the General Committee, in its absolute discretion, to become an honorary member for such period as the General Committee shall determine. Honorary members shall not be eligible to participate in diving activities except with the expressed permission of the General Committee.
- 6.1.3. Life Member who may be any person invited by the General Committee, in its absolute discretion, to become a life member. Life Members are permitted to participate in diving activities.
- 6.1.4. Out-of-port Member - to qualify for this class of membership the person must be in permanent residence outside a 50 mile radius of the Clubhouse and must have been a full member of the Branch for a continuous period of at least 12 months. The membership fee will include the person's B.S.A.C. membership contribution and in all respects will be accepted as a full diving member of the Branch. All applications for this class of membership will be considered individually by the General Committee and membership will be accepted or rejected at the General Committee's discretion.
- 6.1.5. Family Member - This category will apply to BSAC Junior Diving Members (ie, up to age 17), Junior Snorkelling Members (ie, age 6 - 17) or Student Diving Members (ie, over age 18 and in full time education) if accompanied by an adult paying full membership fee, or a B.S.A.C abated member who joins as the third or subsequent diving member of a family group.
- 6.1.6. Social Member – Who will be entitled to attend all Branch activities, but may not participate in any diving or snorkelling activities. Social members are not permitted to vote at Annual or Special meetings, but may be invited to sit on committees formed for the purpose of promoting the non-diving activities of the Branch. Social members are not members of the B.S.A.C.
- 6.1.7. Any person under 18yrs of age whose parent/s or guardian must also be at a minimum, a club social member.
- 6.2. All applications for membership shall be considered by the General Committee, who, on receipt of the appropriate payment of Branch and National Subscriptions as appropriate will accept the applicant to the category applied for or to which they are eligible.
- 6.3. Persons may not be admitted to membership without an interval of at least two clear days between their application for membership and admission.
- 6.4. Only adult diving or snorkelling members shall be entitled to vote at General Meetings or Special Meetings.
- 6.5. All non-voting members must not become significant in relation to the number of voting members.
7. Management
- 7.1. The management of the Branch shall be vested in the General Committee, which shall administer for the general benefit of the Branch all funds, property and equipment in the general ownership of the Branch.
- 7.2. The General Committee shall ensure that the finances of the Branch shall be managed to ensure that it remains in a proper and solvent position.



7.3. Any surplus income or gains shall be retained by the Branch for its future development and shall not be distributed to members or third parties in cash or in kind except that this does not prevent donations by the club to Charities or other clubs registered as Community Amateur Sports Clubs.

8. Trustees

8.1. The Trustees shall hold for the benefit of the members all assets, funds, property and equipment in the general ownership of the Branch.

8.2. The Trustees shall hold office until death or resignation, unless removed from office by a resolution of the Trustee Committee. The number of Trustees shall be not less than five and not more than seven so far as is practicable.

8.3. A Trustee Committee, consisting of all the Trustees and the Officers of the Branch shall be responsible for the appointment or removal of a Trustee, except that such appointment or removal shall not be confirmed until ratified by a majority of the General Committee.

8.4. At any meeting of the Trustee Committee there shall be at least two Trustees and two Officers. The meeting will be chaired by a Trustee appointed for the duration of the meeting. In the event of a tied vote the chairman shall have a second casting vote.

8.5. Following a motion of the General Committee, the Trustees shall consider a request for the Branch to borrow money by way of a loan, mortgage or any other instrument for the benefit of the Members. Provided that the Trustees are satisfied that this is the wish of the Members, the Trustees are authorised to pledge, mortgage or debenture any or all of the Branch assets to satisfy the lending institution. In determining the wishes of the Members, the General Committee shall provide all reasonable facilities to the Trustees to enable them to make their decision in a fair and open manner and Members shall be permitted at all times to have full access to all minutes and documents related to this process.

8.6. In all other matters the Trustees are authorised to sell or otherwise dispose of any of the Branch assets in accordance with the resolution of the General Committee, of which an entry in the Minute Book shall be conclusive evidence, provided that the Trustees are satisfied that this is the wish of the Members. In determining the wishes of the Members, the General Committee shall provide all reasonable facilities to the Trustees to enable them to make their decision in a fair and open manner and Members shall be permitted at all times to have full access to all minutes and documents related to this process.

8.7. Trustees shall be entitled to attend any General Committee meetings and to participate in any discussions, but shall not be entitled to vote on any resolutions placed before the General Committee.

9. General Committee

9.1. The elected members of the General Committee shall consist of four Officers, who shall be the Chairman, Honorary Secretary, Honorary Treasurer and Diving Officer and not more than 8 other members including Equipment Officer, Registrar, Building Manager and Steward.

9.2. The General Committee shall at its first meeting appoint one of its members Vice Chairman.



- 9.3. The General Committee shall take office immediately after the Annual General Meeting at which it is elected and hold office until the close of the next Annual General Meeting.
- 9.4. The General Committee shall meet not less than 9 times in a year of office to examine the Accounts and arrange the affairs of the Branch.
- 9.5. Minutes shall be taken of all proceedings of the General Committee.
- 9.6. The quorum of the General Committee shall be 5 of the members, one of whom must be the Chairman, Vice Chairman or the Honorary Secretary.
- 9.7. The General Committee shall have the power to co-opt members to the General Committee to fill any vacancy among the officers of the Branch, among its other members or of the Auditors which occurs in its term of office and shall have the power to co-opt any other members it sees fit, except that members co-opted other than to fill a vacancy shall not be entitled to vote on resolutions before the General Committee.
- 9.8. The General Committee may appoint from among their number or from the general body of members such Sub-Committees as they may deem necessary or expedient and may depute or refer to them any of the powers and duties of the General Committee, except those given under bye-laws 17 and 19.
- 9.9. The General Committee shall determine any question as to the interpretation of these bye-laws and of any regulations made hereunder and may rule in connection with any situation not otherwise provided for herein. In the latter event, such ruling shall only remain in effect until the next Annual General Meeting of the Branch or a Special General Meeting called for that purpose. Its continued validity shall depend upon ratification at that meeting.
- 9.10 No member shall occupy a single position on the General Committee for a continuous period of more than 5 years. No member shall sit as a General Committee member, in any combination of positions, for a continuous period of more than 7 years. Following a continuous period of 7 years on the General Committee a member shall not stand for election to the General Committee until after the second Annual General Meeting following the end of their term of office.

10. Honorary Treasurer

- 10.1 The Honorary Treasurer shall be responsible for dealing with all monies received or paid on behalf of the Branch, and shall keep proper books of account of all monies received or paid on behalf of the Branch and shall effect in the name of the Branch, and keep records of, all investments by the General Committee. The Honorary Treasurer shall arrange for all such monies and securities to be deposited at such branch of a Bank or Building Society as the General Committee may approve to the credit of an account in the name of the Branch, on which cheques and other orders shall be signed by two of three officers of the General Committee as nominated by the General Committee members
- 10.2 Treasurer shall be responsible for the calling in and collecting of all debts and subscriptions and for the due discharge of all liabilities of the Branch out of Branch funds as the General Committee may direct. The Honorary Treasurer shall prepare a statement of income and expenditure and a balance sheet to 31st December of each year, which shall be the end of the Branch year and The Honorary Treasurer shall



cause it to be **reviewed** by the Branch **Accountants** and presented to the General Committee for submission to the Annual General Meeting. The Honorary Treasurer may be assisted in his work by such person or persons as the General Committee may approve.

11. Annual General Meeting

11.1 The Annual General Meeting of the Branch shall be held not later than 31st March in each year, upon a date and a time to be fixed by the General Committee, for the following purposes:

11.1.2 To receive from the General Committee a Report, balance sheet and Statement of Accounts for the preceding year.

11.1.3 To appoint the General Committee and Officers, by a secret ballot, and to appoint Accountants for the ensuing year.

11.1.4 To decide on any resolution which may duly be submitted to the meeting, as herein provided?

11.2 Notice of the Annual General Meeting of the Branch shall be sent by post or otherwise delivered to all paid-up members at least six weeks before the meeting. A copy of this notice shall be posted in the Clubhouse at the same time.

11.3 All nominations must be delivered to the Honorary Secretary at least 28 days before the meeting, proposed and seconded and signed by the nominee that he/she is willing to accept the position if he/she is elected.

11.4 The notification of the meeting shall also include a request to members for motions for consideration at the meeting. These must be proposed and seconded and delivered to the Honorary Secretary not less than 28 days before the meeting.

11.5 A further notification shall be sent by post or otherwise delivered to all paid-up members at least 2 weeks before the meeting listing in detail the business of the Annual General Meeting including any motions which have been proposed and listing election details. A copy of this notice shall be posted in the Clubhouse at the same time.

11.6 The Agenda shall include:

11.6.1 Apologies for absence;

11.6.2 Minutes of the previous AGM and any General Meetings which have occurred since that date;

11.6.3 Matters arising from those Minutes;

11.6.4 Reports from Officers;

11.6.5 Election of the General Committee;

11.6.6 Motions of which notice has been given

11.6.7 Other business as the Chairman may select.

11.7 A quorum at the Annual General Meeting shall be 1/5th of voting members, but a quorum once formed shall not be lost despite the departure from the meeting of any member or members



11. Special General Meeting

12.1 Any General Meeting other than the Annual General Meeting shall be known as a Special General Meeting.

12.2 A Special General Meeting may be called by the General Committee at any time.

12.3 A Special General Meeting may be called by the written request of not less than 2 Trustees at any time

12.4 The General Committee shall convene a meeting within 2 months of the receipt of the request.

12.5 A Special General Meeting may be called by the written request of not less than 12 paid-up voting members or fifty percent of the paid-up voting members, whichever is the greater. This request shall state the reason for the meeting and be signed by all the members calling the Special General Meeting. The General Committee shall convene a meeting within 2 months of the receipt of the request.

12.6 A Special General Meeting may be called by a member who has been suspended under bye-law 19.

12.7 Notice of a Special General Meeting of the Branch shall be sent by post or otherwise delivered to all paid-up full voting members at least 14 days before the meeting, together with a statement for the reason of the meeting. A notice shall also be posted in the Clubhouse at the same time.

12.8 The business of a Special General Meeting shall be that for which it was called and no other.

12.9 A quorum at a Special General Meeting shall consist of 1/5th of the voting members but a quorum once formed shall not be lost despite the departure from the meeting of any member or members.

13. Voting

13.1 Except as otherwise provided, voting at General Meetings or Special General Meetings shall be by show of hands or by ballot of voting members as the Chairman may decide and except as otherwise provided a motion shall be passed by a simple majority.

13.2 Voting papers for any ballot being conducted by post shall be sent to all members not less than 14 days before the date on which the votes are to be counted. A postal ballot will be considered to have been passed if not less than 1/5th of the members have cast a vote and that a simple majority of those voting agree with the motion.

13.3 Every voting member shall be entitled to one vote upon every motion.

14. Branch Activities

14.1 The Branch activities shall be open to members of other Branches at the discretion of the person in charge

14.2 The use of the training pool will be directed by the Diving Officer or his/her representative.

14.3 If a member damages or loses Branch equipment, the General Committee may charge that member the cost of repairing or replacing the article. The General Committee



may similarly charge a member who damages or loses private property used in connection with Branch activities

15. Charges

15.1 Persons joining or re-joining the Branch shall pay such entrance fee as may be determined from time to time by the General Committee.

15.2 Subscriptions shall be renewable annually in October. Persons joining any time between will pay one full year's subscription and in October will pay an adjusted fee to align their renewal date in October.

15.3 A member shall retain his/her membership until he/she has resigned or is deemed to have resigned in accordance with this paragraph or bye-law 19. If payment of his Branch or National Headquarters subscriptions, if any, in respect of any period is 3 months or more overdue, a member shall be deemed to have resigned.

16. Bar

16.1 The bar shall be managed and operated by a Bar Sub-Committee, hereinafter called the Bar Committee, consisting of not less than five members, at least two of whom shall be members of General Committee

16.2 In the event that a member nominated to the Bar Committee resigns or leaves their position, the General Committee shall immediately appoint another person in their place.

16.3 Bar opening times will be in accordance with current permitted licensing hours.

16.4 The purchase for the Branch and the supply by the Branch of intoxicating liquor shall be in the absolute discretion of the Bar Committee.

16.5 Part 4 of the Licensing Act 2003 is adopted and there shall be no sale of intoxicating liquor by or on behalf of the Branch to any person not a member for consumption on the Branch premises under any bye-law except:

16.5.1 Guest of the Branch - Every member of 18 years and over shall be allowed to introduce one guest on twelve separate occasions per year subject to such regulations or bye-laws as shall be made from time to time by the Bar Committee. Every guest shall be considered the guest of and shall be accompanied by the member introducing him/her, provided that no person shall be introduced as a guest into the Branch who shall have been expelled from membership or whose conduct or presence in the Clubhouse shall be considered by the Bar Committee to be objectionable or injurious to the interests of the Branch. All guests shall be required to sign the visitor's book.

16.5.2 B.S.A.C. Officials, visiting clubs and bona fide guests taking part in any event organised by the Bar Committee or any sub-section or sub-committee may be invited and admitted to the Branch premises and intoxicating liquor may be sold or supplied to such persons on behalf of the Branch for consumption on the Branch premises and not anywhere else. Such visitors must supply the Bar Committee with a list of names and addresses of those attending. Such list must be entered into a book especially kept at the Branch for such purposes to be produced to a Police Officer on demand. It should also include members of another Branch and its officials whose own club is temporarily out of use and who have been permitted by the General Committee to use the facilities of the Branch.



16.6 Individual members may apply in writing to the Bar Committee to hold a function for a special occasion in the Branch. The members so organising such functions must be present at the function and must submit to the Bar Committee a list of names and addresses of the guests who are expected to attend the function and such list must be kept in the Branch. Intoxicating liquors may be sold or supplied to visitors in accordance with paragraph 16.5.2

16.7 There shall be no sale or supply of intoxicating liquor to any person under the age of 18yrs.

16.8 For a non member to hire the club a temporary events notice (TEN) form must be filled in. The person hiring must be over 18. This must be received by the relevant licensing authority (in duplicate) and must be accompanied by the prescribed fee and a copy of the TEN must be sent to the relevant chief officer of police, no later than 10 working days before the event. There must be 24 hours between events. Only 12 of these events can be applied for a year, and only five per a person. This is not needed for a member to hire the club. The General Committee has the right to refuse an event if it is seen as a risk to the club or members.

16.9 There shall be no alterations to the bye-laws of the Branch so as to authorise sales not authorised on the club premises Certificate under section 4 of the Licensing Act 2003

16.10 The Secretary of the club is responsible for the club premises certificate and must ensure it is kept on the premises (Licencing Act 2003 94.2) They are also responsible for giving the relevant licencing authority notice of any changes to the bar bye-law (82.1) within 28 days of them being changed (Licencing Act 2003 82.1)

17. Resignation from General Committee

The General Committee shall have the power by a two-thirds majority of all its members to request the resignation of any officer or member of the General Committee. Failing compliance within seven days of such a request, such officer or member shall be deemed to have resigned.

17.1 Before requiring the resignation of an officer or member, the General Committee shall give that person the opportunity of appearing before the General Committee, of hearing the reason for such request to resign and of addressing the General Committee in answer to such reason. The officer or member shall be permitted to be accompanied at such a hearing by their nominated representative, who shall be permitted to speak for or to act as a witness for that officer or member.

18. Temporary suspension from participation

In order to ensure the safety and good name of the Branch and its members, the person in charge of a Branch activity may suspend, at his discretion and for the duration of the activity, any member who misconducts himself. Any such suspension shall be reported as soon as possible to the Chairman or the Diving Officer and must be discussed at the next meeting of the General Committee.

19. Suspension and Loss of Membership

Where a member is considered to have brought the Branch into disrepute, or where the activities of a member might be considered to be a matter of gross misconduct then that member shall be suspended by the Chairman or Diving Officer, such suspension being



confirmed in writing within ten days of the notification, and the following procedure for considering the future membership status of that person shall be used:

19.1 At all stages of the procedure, the suspended member shall be entitled to be accompanied by a nominated representative, who shall be permitted to speak for the suspended member, or to act as a witness for that person procedure, the suspended member shall be entitled to be accompanied by a nominated representative, who shall be permitted to speak for the suspended member, or to act as a witness for that person

19.2 In the first instance, the suspended member will have the right to hear the reason for the suspension and to discuss it in private at a meeting between the suspended member (and a witness) and the Chairman and Honorary Secretary or the Chairman and Diving Officer. If the suspension is dismissed, the minutes of the meeting shall be returned to the member, and no further record shall be kept of the details of the incident leading to the suspension, except where such an incident would have led to an Incident Report being filed with the B.S.A.C. Head Office.

19.3 If the suspension is upheld at this meeting, then the suspended member (and a witness) shall have the right to present their case before a meeting of the whole General Committee.

19.4 If at the meeting of the whole General Committee the suspension is upheld by a 2/3rds majority of all its members, then the member will be expelled from the Branch with immediate effect, such decision being confirmed to the member in writing within seven days of the hearing.

19.5 The expelled member can appeal the General Committee's decision by asking for a Special General Meeting to be held within six weeks of the date of that letter. At the meeting the member whose expulsion is under consideration shall be allowed to offer an explanation of such conduct verbally or in writing. If 2/3rds of the members present shall vote for their expulsion, the member shall cease to be a member of the Branch. The voting at such Special General Meeting shall be by ballot if not less than five members present shall so demand.

19.6 At all stages in the procedure, the Chairman shall use his/her best endeavours to ensure that the hearings are held as soon as possible, and to suit both the suspended member and the General Committee. Any hearing shall not be unduly delayed by reason of the unavailability of any member or members.

20. Dissolution

If at any General Meeting of the Branch a resolution be passed for the dissolution of the Branch, the membership list of the Branch shall immediately be closed. Such resolutions shall at a Special General Meeting, held not less than one month thereafter and attended by not less than one-half of the voting members of the Branch, be confirmed by a majority of two-thirds of the members being present. The General Committee shall there upon, or at such date as shall have been specified in the resolution, proceed to realise the property of the Branch and after the discharge of all liabilities, shall hand over the net assets to other clubs in the local area whose aims and objectives are consistent with a Community Amateur Sports Club or other Charitable causes.



21. Amendment

21.1 Subject to 21.3 these bye-laws may be added to, repealed or amended by resolution at any Annual or Special General Meeting, provided that no such resolution shall be deemed to have been passed unless it be carried by a majority of at least two-thirds of the voting members present at that meeting.

21.2 Subject to or interpretation of these bye-laws made by the General Committee under bye-law 9.9 shall be confirmed or set aside at the next Annual General Meeting thereafter or at a Special General Meeting called for that purpose

21.3 Except that any bye-laws added to, repealed or amended in accordance with bye-laws 21.1 or 21.2 shall not become effective until after a certified copy of the new bye-laws has been delivered to The Clerk to the Justices, Macclesfield Magistrates and The Divisional Commander, Macclesfield Police, and that they have confirmed their receipt thereof.

22. British Sub Aqua Club Rules

These Bye-laws are made in compliance with Rule 3 of the Rules of the B.S.A.C., shall be subject to the provisions and requirements of that Rule, and shall only be valid to the extent that they are not in conflict with the said provisions and requirements or with those of the Articles of Association of the B.S.A.C.

1.0 INTRODUCTION

East Cheshire Sub Aqua Club (ECSAC) was established in 1960, its purpose being to provide a facility that will allow any interested individuals to take part in Scuba Diving or Snorkelling in a controlled and effective manner.

ECSAC is a Community Amateur Sports Club (CASC 00728). This means that there are benefits such as the ability to raise funds from Individuals under Gift Aid. A registered CASC can claim up to £ 28 in tax for every £100 donated. There is also business rate relief exemption from Corporation Tax and Property income both with specific limits. In effect the club is deemed to be an asset to the community and as such is better able to obtain a grant because any grant is recognised as being a benefit to the Community not the individual club members.

2.0 Club Controls

The controlling documents are the Bye Laws, this Manual together with, Documented Procedures (DP), Committee Members responsibilities (CM), Standard Forms (SF), Check Lists (CL) and relevant Statutory and Regulatory requirements. To this end the rules of the Branch to which each member shall be bound shall be those currently adopted by the British Sub-Aqua Club (hereinafter called "B.S.A.C.") and in addition each member shall be



bound by the relevant (ECSAC) bye-laws which is the primary ruling document within the management system:

3.0 Headquarters

The headquarters of the Branch is 2, Lower Bank Street, Macclesfield SK11 7HL (From Bye Laws)

4.0 Club Location

The Branch may maintain for the convenience of its members a Clubhouse. Such Clubhouse will operate under the name of East Cheshire Sub-Aqua Club, the control of which is vested in the Branch General Committee (hereinafter called the General Committee). (From Bye Laws)

5.0 President

See Bye Laws

6.0 Membership

See Bye Laws for details

7.0 Management

The management of the Branch shall be vested in the General Committee, which shall administer for the general benefit of the Branch all funds, property and equipment in the general ownership of the Branch (See Bye Laws)

8.0 Trustees

The Trustees shall hold for the benefit of the members all assets, funds, property and equipment in the general ownership of the Branch. (See Bye Laws for details) A list of trustees is attached to this document.

At any meeting of the Trustee Committee there shall be at least two Trustees and two Officers. The meeting will be chaired by a Trustee appointed for the duration of the meeting. In the event of a tied vote the Chairman shall have a second casting vote. (see By Laws for details)

9.0 General Committee (Summary)

The elected members of the General Committee shall consist of four Officers, who shall be the Chairman, Honorary Secretary, Honorary Treasurer and Diving Officer and not more than 8 other members including Equipment Officer, Registrar, Building Manager and Bar Manager (Steward From Bye Laws)

General Committee shall meet not less than 9 times in a year of office to examine the Accounts and arrange the affairs of the Branch. (see Bye Laws for Details)

The quorum of the General Committee shall be 5 of the members, one of whom must be the Chairman, Vice Chairman or the Honorary Secretary

General Committee shall have the power to co-opt members to the General Committee to fill any vacancy among the officers of the Branch, among its other members or of the Auditors which occurs in its term of office and shall have the power to co-opt any other members it sees fit, except that members co-opted other than to fill a vacancy shall not be entitled to vote on resolutions before the General Committee.

The General Committee shall have the power to co-opt members to the General Committee to fill any vacancy among the officers of the Branch, among its other members or of the **Accountants** which occurs in its term of office and shall have the power to co-opt any other members it sees fit, except that members co-opted other than to fill a vacancy shall not be entitled to vote on resolutions before the General Committee

No member shall occupy a single position on the General Committee for a continuous period of more than 5 years. No members shall sit as a General Committee member, in any combination of positions, for a continuous period of more than 7 years. Following a continuous period of 7 years on the General Committee a member shall not stand for



election to the General Committee until after the second Annual General Meeting following the end of their term of office. (Note for full details refer Bye Laws)

10.0 Annual General Meeting (AGM)

The Annual General Meeting of the Branch shall be held not later than 31st March in each year, upon a date and a time to be fixed by the General Committee, for the purposes identified in the Bye Laws:

The Agenda shall include:

Apologies for absence;

Minutes of the previous AGM and any General Meetings that have occurred since that date;

Matters arising from those Minutes;

Reports from Officers;

Election of the General Committee;

Motions of which notice has been given

Other business as the Chairman may select.

A quorum at the Annual General Meeting shall be 1/5th of voting members, but a quorum once formed shall not be lost despite the departure from the meeting of any member or members

10.1 Special General Meeting

Any General Meeting other than the Annual General Meeting shall be known as a Special General Meeting.

A Special General Meeting may be called by the General Committee at any time. (See Bye Laws)

11.0 Officers

The Club shall have the following Officers: -

Chairman, Honorary Secretary, Honorary Treasurer and Diving Officer together with: - Registrar, Equipment Officer, Building Officer, Bar Manager (Representative) and four general members.

12.0 Officers Responsibilities

CM 01Chairman

Is responsible for chairing all meetings except when not available when the Vice Chairman will cover. The Vice Chairman to be nominated by the Chairman. The Chairman is a signing authority for cheques and other financial activities and signs the minutes as a fair reflection of what took place at each meeting. Has a responsibility to ensure that the club is functioning in an acceptable manner. Holds the master copy of the clubs management system including the Asset Register. Has a responsibility to see that the requirements of the management system and the legal and regulatory requirements are complied with.

CM 02Honorary Secretary

Is responsible for the administration of the club and prepares the minutes and the agenda together with retaining the clubs contacts and ensuring present and past members are advised of events. The Secretary normally has signing authority for cheques. Is responsible for the administrative records of the club and traditionally has the role of organising the Annual Dinner Dance. (See bylaws 10.2)

The Secretary is also responsible for the club premises certificate (Licencing Act 2003 82.1) and advising the relevant licencing authority of any changes to the bar bye laws (82.1) within 28 days of them being changed (Licencing Act 2003 82.1). The Secretary should also ensure that the club has a relevant licence to run raffles.

CM 03Honorary Treasurer



The Honorary Treasurer shall be responsible for dealing with all monies received or paid on behalf of the Branch, and shall keep proper books of account of all monies received or paid on behalf of the Branch and shall effect in the name of the Branch, and keep records of, all investments by the General Committee. The Honorary Treasurer shall arrange for all such monies and securities to be deposited at such branch of a Bank or Building Society as the General Committee may approve to the credit of an account in the name of the Branch, on which cheques and other orders shall be signed by two of three officers of the General Committee as nominated by the current General Committee. The normal preference is for at least two of the following officers, the Treasurer, Honorary Secretary, Chairman or the Diving Officer. There is however, through the Bye Laws, the opportunity to appoint any other committee members in this role where it is deemed to be appropriate for the clubs benefit

Treasurer shall be responsible for the calling in and collecting of all debts and subscriptions and for the due discharge of all liabilities of the Branch out of Branch funds as the General Committee may direct. The Honorary Treasurer shall prepare a statement of income and expenditure and a balance sheet to 31st December of each year, which shall be the end of the Branch year and The Honorary Treasurer shall cause it to be reviewed by the Branch **Accountants** and presented to the General Committee for submission to the Annual General Meeting. The Honorary Treasurer may be assisted in his work by such person or persons as the General Committee may approve. **(Bye laws)** Is responsible for controlling and managing the clubs finances and reporting the situation at each monthly management meeting. The treasurer is a signing authority for cheques and financial matters. This activity requires two authorised signatures for any cheque or other financial transaction from the three approved signatories. Is responsible for the retention of all applicable financial records appertaining to the club and preparing the accounts for audit as required.

CM04 Diving Officer

Is responsible for all diving activities within the club as required by BSAC. Is responsible for authorising club dives and no diving may take place without his/her approval. Ensures dives have the relevant number of competent divers for the planned dive. Is responsible for the activities of the Training Officer when reporting concerns or status at the Committee meetings. Is responsible for the records for the diving equipment and dives that were carried out.

CM 05 Registrar

Is responsible for holding a controlled list of all members and their current membership status together with their contact details. Advises members when their subscriptions are due and collects the ECSAC fees together with the BSAC fees. Holds the current membership fees for every grade of member (See Bye Laws) and is responsible for advising each member of the fees they should pay based on the Committee meeting agreed figures for that year. Responsible for passing the membership receipts to the treasurer.

CM 06 Equipment Officer

Is responsible for identifying the condition of all equipment used for diving. He/She may appoint other club members to take responsibility for specific items such as Boats, Compressor, etc but will report the situation to the committee at the monthly meeting.

CM 07 Building Officer

Is responsible for the condition of the building and all its facilities including the condition of fire equipment, kitchen equipment, electrical equipment and all services related to the building. Is in control of the Keys to the building and the issue of Keys to Key holders to ensure adequate security. Deals with licences and approvals from external bodies where



they relate to the building and its safe operation. Controls, together with the Bar Representative, any function held at the club. The building Officer is responsible for ensuring that booked dates are registered after confirmation with the Bar Representative to ensure the dates required can be covered by volunteer staff and to prevent double booking

CM 08 Bar Manager (Steward)

The Bar manager is responsible for ensuring that the ECSAC Bye laws covering the bar (Section 16) are complied with. They are also responsible for the general running of the bar which includes cleaning line's ordering the beer, recycling the rubbish in the bar area, cashing the till each week (banking & change orders can be done by the Bar Manager (BM) or given to the treasurer to do if you don't have time as long as there is a record of everything that goes in and out of the till). The BM is also responsible for staffing the bar for normal nights and doos, keeping bar area tidy and dealing with the cleaners. The Bar Manager has the authority to place orders for drink and snacks held by the bar and the monitoring of the usage and modifying what is purchased in light of experience. The Bar Manager also has 2 sets of keys, one is for their own use and the other is to be used at the BM's discretion for bar committee and club members who need them for obtaining the boats or running doos etc but only for established members who the committee can trust. BM is responsible for ensuring the Keys are returned after use. The Bar Manager is one of two committee members responsible for approving the hiring out of the club and must comply with the bye laws.

CM 09 General Committee Members

All general committee members have the same voting rights as the other committee members and this role is a supportive role where other activities are often taken over by these committee members. They may be co-opted onto or lead a sub committee for a specific requirement or they may take on any other role as the committee see fit.

13.0 Club functions

All club functions are dependent on a valid "Club premises Certificate" with formal evidence of the payment of the appropriate annual licence fee. Club Functions are controlled by the use of Club Function Booking Form, which must be filled in by the person who wishes to use the club.

The form SF09 01 Club booking form must be approved by both the Bar Manager and the Building Manager . The fees for this are identified on the form and paid to the Bar Manager for submission to the Honorary Treasurer.

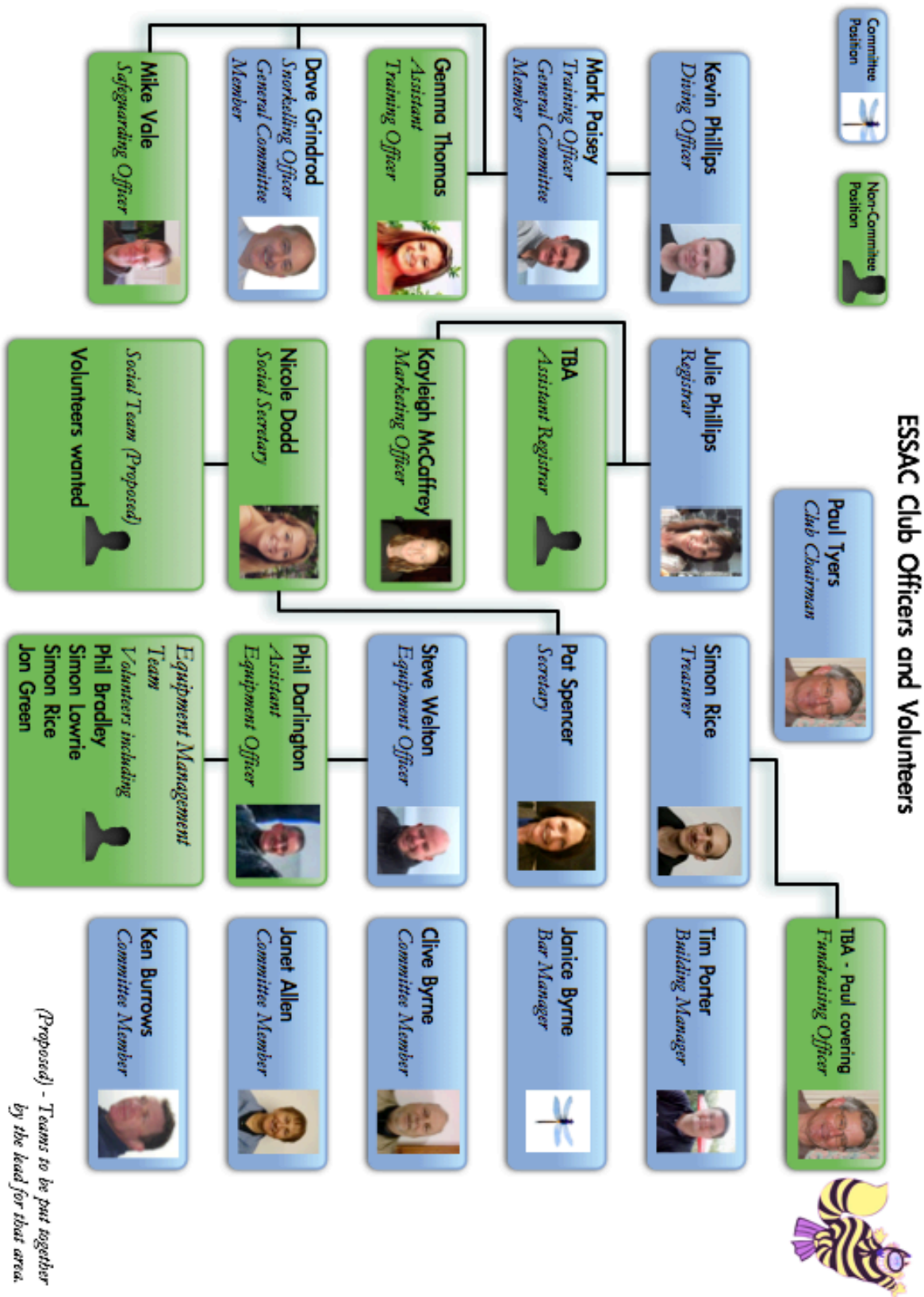



7.11 Boat Storage Proposal

ECSAC Committee Proposal

1. Proposal summary

The proposal is to store (relocate) one of the club boats to a boat yard on Anglesey for a proportion of the year in 2015. The boat yard we recommend would be ABC Powermarine in Beaumaris.

We would recommend TopCat is the boat that is stored due to the likelihood that the Delta will need more maintenance than TopCat and this can be more easily carried out while in the Macc Boat House. It will also mean that (as planned) TopCat would get more use as the Delta would only be used when two boats are needed for a trip. If maintenance were required on TopCat this could either be carried out in situ or potentially the boats could be swapped over on a dive weekend if/when both boats are on the same trip.

Central to the proposal of boat storage is the concept of improved access and utilisation. The current model of planned trips with 2 weeks notice and trailering the boat to Anglesey is inflexible in that a suitable tow vehicle is required and the weather needs to be appropriate or the trip is cancelled, costs are also significant and as a result prohibitive for some types of use.

Moving the boat to Anglesey for spring/early summer storage aims to address these issues. Clearly the storage needs to be cost effective, secure and accessible. A number of sites were identified, Holyhead, Treardurr Bay, Port Dinorwic (Dinas) and ABC Powermarine. HH has security issues and probably has not been explored fully but operating out of a busy harbour all summer is probably not ideal. Dinorwic is mid Menai Straits and whilst suitable as a base for storage requires the boat to be trailered to launch sites defeating the point of the proposal.

ABC Power marine is 4nm from Puffin and outside the Swellies giving access from the boatyard to Puffin, North Coast sites, Great Orme Head sites and deeper offshore sites. Within a 15 nm range there are many dive sites available. The slipway is useable +\ - 3 hours of HW, outside of this a tractor launch and recovery service is provided for £24. This means a day dive akin to a trip to Capernwray is achievable, i.e. no tow vehicle is required. Multi day trips can utilise B&Bs or camping in Beaumaris and the new shower/toilet facilities block at the boatyard (hot showers!) In addition should the boat be required elsewhere on the island (or on the Lleyn) it can be collected and towed as needed but at a much lower cost the trip participants, this must lead to increased utilisation and return additional fees to the club.


From a boat handling training perspective the Beaumaris area offers distinct advantages over other sites as the North channel is buoyed and this will provide an enhanced training area for Seamanship events. Increasing the diving opportunities both in numbers of dive trips and type eg SDCs and good inshore dives (Puffin Island in particular). This will lead we hope to increased interest and keep people in the club.

Whilst this is primarily aimed at the club members a spin off is that spare boat spaces (if there are any) could be offered regionally or to other clubs via ex members eg Ian Ross at a suitable charge rate this may advertise the club effectively and promote growth!

This is a proposal only in that it is of course reversible. Let's try a trial period and review it afterwards.

2. Costs

Boat storage will cost £16 per week (for 10 weeks or longer). We would propose to store the boat immediately after the early season boat trip (early April – Easter) as a trial and aim for an initial 10-week period through to Mid June. This would cost £160.

A cover would be needed for the boat, we would propose this was sourced via the club (large clean tarpaulin would be satisfactory).

3. Charging Proposal / Programme of Use

Charging

We would suggest that a simple charging process is adopted to ensure that it is easily managed and recoups the cost of storage as well as returning some wear and tear money to the club.

The proposed charging mechanism would be £5 per day per user (same for divers as trainee boat handlers/trainees etc). Plus a share of the cost of fuel (and launch fees if these are incurred) as per the current trip calculator (including the 15% wear and tear surcharge).

E.G. 5 divers using the boat for a single day = £5 each + petrol/W&T.
 Assume £40 fuel, thus trip cost = £25 + £40 + £6 W&T = £71 = £14.20 each

Assuming we launch the boat ourselves. If we use the launch facility then the price would be £19 in this example.

For 6 divers the cost would be £16.70 each with a launch or £12.70 with a self launch.

This simplicity and pricing will encourage more diving!



4. Cost Benefit / Breakeven

Assuming the costs are as expected then the breakeven point for the first 10 weeks storage would be reached at 6 days usage with 5 divers on the boat (30 diver days – that is just two Bank Holidays!).

However based on an expected 55 diver days minimum usage (that is just Easter + 2 May Bank Holidays and one extra weekend with 5 divers using the boat i.e. 11 days usage for 5 divers = 55 diver days) we would see a return to the club of £180. This will completely cover the storage charge; it will also return an additional income to the club for maintenance.

If we assume a minimum of 55 diving/training days are conducted in the 10-week trial period then a total of £181 will be returned to the club in usage fees and wear and tear fees.

10 weeks Storage Costs	= £ 160
Usage charge 55 days (three bank holidays + 1 weekend with 5 divers)	= £ 275
Fuel wear and tear surcharge 15% of £40 per day fuel	= £ 66

Net income	= £ 181

If we were able to increase the diving to say 180 diver days (that is just 6 divers in the boat for 30 diving days or 5 divers for 36 diving days) over a full season then the charging proposal here would return a net income to the club of over £600.

4. Recommendation

We therefore recommend that the committee agree to site the boat at ABC Powermarine for the first 10 weeks of the 2015 season and adopt the simple charging mechanism³ outlined in this proposal as well as ratify the simplified trip approval/announcement process outlined at Annex B.

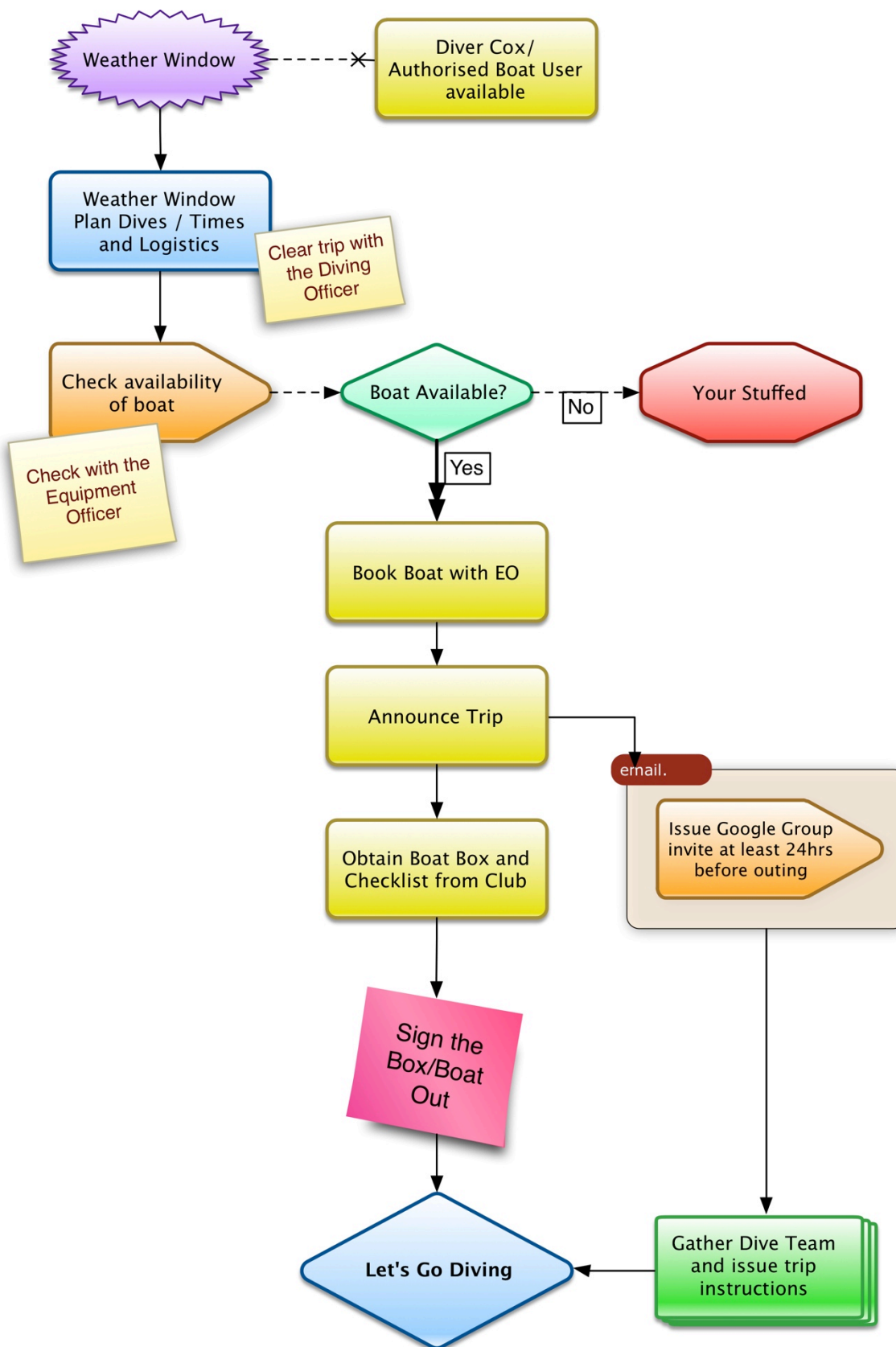
